## AUTOMATIC ANNOUNCEMENT SERVICES

#### General

Regulations contained herein are specific to the services involved and in addition to the General Regulations applicable to all services of the Company.

The Company will provide Announcement Service, subject to the availability of facilities, by means of (C) which a customer will be enabled to furnish to calling parties simultaneously, announcement service of the kind specified herein.

Announcement equipment must be provided by the customer.

Facilities affording the same or similar announcement services may be furnished to more than one customer in an exchange.

The customer to Automatic Announcement Service may use such service for the transmission of material for which a consideration is paid to him by another person.

The customer will be required to contract for as many Announcement Lines as in the judgment of the Company are required to handle the traffic satisfactorily.

One (1) listing without charge will be furnished with each Automatic Announcement Service.

The Company, upon request, will furnish the name and address of the customer and/or party(C)responsible for Automatic Announcement Service as associated with such service in the Company's(C)files.(C)

The customer agrees to indemnify and save the Company harmless against all claims arising from the material transmitted over facilities furnished hereunder, including claims for libel, slander, fraudulent or misleading advertisements, infringement of copyright or any other claims, and against all claims arising out of any act or omission of the customer in connection with facilities provided by the Company. (C)

The calling party who places a call to an Automatic Announcement Service telephone number is responsible for any charges between the originating location and the Automatic Announcement Service telephone number.

# AUTOMATIC ANNOUNCEMENT SERVICES (cont'd)

#### General (cont'd)

The liability of the Telephone Company for damages arising out of mistakes, omissions, interruptions, delays, or errors or defects in transmission occurring in the course of furnishing service or other facilities and not caused by the negligence of the customer, or of the Telephone Company in failing to maintain proper standards of maintenance and operation and to exercise reasonable supervision, shall in no event exceed an amount equivalent to the proportionate charge to the customer for the periods of service during which such mistake, omission, interruption, delay, or error or defect in transmission occurs. However, if, in the case of such interruption, service is restored on or before the day after said interruption is reported to or detected by the Telephone Company, no allowance will be made.

Time and Time-Temperature Announcement Services

The Telephone Company will provide Automatic Announcement Service to permit a customer to furnish time or time-temperature announcements. The announcement equipment must be provided by the customer.

In the Indianapolis Exchange this offering is limited to Time Announcement service only.
