9.3 MESSAGE TOLL SERVICES

9.3.2 OPTIONAL DISCOUNT TOLL CALLING PLANS

A. DESCRIPTION

Optional Discount Toll Calling Plans are furnished as an adjunct to existing toll service and provide for discounted customer dialed toll calling to any intraLATA location. The following Optional Discount Toll Calling Plans are identified below:

The BONANZA Plan for business customers. The COMSTOCK Plan for residential customers.

1. The Bonanza Plan – Business

The Bonanza Plan is an optional intrastate, intraLATA discounted long distance service available to business customers. The Bonanza Plan discounts are given on a threshold basis once a certain level of toll charges have been incurred. See rates and charges for tiered discounts. Term discounts also apply to business accounts who contract for a 1-3 year service contract for discounted long distance. See the Rates and Charges section for applicable discounts and terms.

2. The Comstock Plan - Residence

The Comstock Plan is an optional intrastate, intraLATA discounted long distance service available to residential customers. The Comstock Plan discounts are given on a threshold basis once a certain level of toll charges have been incurred. See rates and charges for tiered discounts.

B. REGULATIONS

- 1. Provisions of the Optional Discount Toll Calling Plans apply to users of long distance direct dialed toll service.
- 2. Discounts will apply on an account level only.
- 3. Person-to-person, collect, conference, third number billed, toll station, Express Call Completion or any call requiring operator handling will be billed the appropriate operator surcharge as defined in the applicable guidebooks.
- 4. Optional Discount Toll Calling Plans will carry no recurring or nonrecurring charge. However, customers must sign up for the plans via a service order.
- 5. The Bonanza Plan will not affect customers of Dial One Metro optional calling plan identified in Part 20, Section 9 of this Guidebook. Business Customers can subscribe to both Dial One Metro Plan and the Bonanza Plan described in this Guidebook.
- 6. Term discounts apply to business customers on a contractual basis. Term discounts will be applied after the Bonanza discount is given.

DIAL ONE METRO/1/

A. Description

Dial One Metro is an optional intrastate, intraLATA long distance business service which allows long (C) distance calls to be made within applicable EADs as described in Part 4, Section 1 of this Guidebook and noted in C. Rates and Charges, at a flat fixed rate.

B. Regulations

- Dial One Metro service is furnished as an adjunct to individual line business service and provides for customer dialed telephone communication to the EAD service area defined herein. The service is a one way service provided for and applicable to originating calls only. The plan does not apply to incoming calls.
- 2. The provisions of the plan apply only to originating calls which are directly dialed from a line which has been identified by the customer through subscription to the plan. Person, collect, conference, third number billed, toll station and any other call requiring operator handling are not included and will be billed at the Message Telecommunication Service (MTS) rate from this Guidebook appropriate for the type of call. Calls to points not within the defined service area are likewise subject to the rates and conditions specified for MTS.
- 3. The Dial One Metro optional calling plan will not be furnished in connection with foreign exchange service, except when a foreign exchange service is extended from an EAD eligible under the plan to another EAD likewise eligible under the plan. Dial One Metro will not be furnished in connection with Wide Area Telecommunications Service (WATS) or Customer Owned Public Telephone Service (COPTS).
- 4. The provision of satisfactory transmission is contemplated only between the station with which the individual line is associated and the called station. The service is not represented as adapted for interconnection physically, acoustically or by any other means to any other line, facility or service at the customer's premises to extend a two-point connection beyond the originating station and the called station. Dial One Metro may be furnished in conjunction with Remote Call Forwarding Service as defined in Part 7, Section 4 of this Guidebook. 5. Dial One Metro is not available on any exchange access line that is restricted from the capability of making long distance calls.
