The purpose of this Supplement is to cancel Supplement No. 19, issued February 17, 1995, and to replace it to reflect the Rate Adjustment Factors (RAFTs) and revised rates as listed below.

SWBT originally filed Supplement No. 16 in compliance with the Bureau's Order in CC Docket No. 94-97, the Virtual Collocation Tariff Suspension Order, released December 9, 1994, and Erratum, released December 12, 1994. In Supplement No. 16, the Expanded Interconnection tariff revisions which were filed under Transmittal No. 2383, and subsequently revised under Transmittal Nos. 2388, 2392, 2397 and 2407, were advanced for one day to December 14, 1994 and suspended for one day to December 15, 1994, and employed the RAFTs outlined in the Bureau's Order. Subsequently, in the Erratum released February 10, 1995 in CC Docket No. 94-97, the Bureau addressed certain proposed rate elements which were filed in Transmittal No. 2407, but were inadvertently neglected in Appendix C of the Bureau's Virtual Collocation Tariff Suspension Order. These rate elements were included in Supplement No. 19, which canceled Supplement No. 16, and became effective on February 18, 1995. In addition, SWBT revised rates originally filed in Supplement No. 16 which reflected the application of an incorrect RAFT.

At this time, pursuant to Commission directive, SWBT proposes to revise the rate elements that were originally filed in Transmittal No. 2407 and subsequently revised in Supplement No. 19. At the direction of the Commission, these rates are being revised to reflect the application of the RAFTs that were specified in Appendix C of the Bureau's Virtual Collocation Tariff Suspension Order.

In addition and at the direction of the Commission Staff, SWBT proposes to apply the RAFT specified in Appendix C of the Bureau's Virtual Collocation Tariff Suspension Order to the ADC SONEPLEX 2000 (SONEPLEX) rates filed under Transmittal No. 2407. SWBT originally filed the SONEPLEX rates under Transmittal No. 2397 and subsequently revised those rates under Transmittal No. 2407. Appendix C of the Bureau's Virtual Collocation Tariff Suspension Order neglected to reflect the revised SONEPLEX rates filed under Transmittal No. 2407. This Supplement clarifies that the RAFTs are applied to all rates as of December 15, 1994.

Pursuant to the Bureau's Virtual Collocation Tariff Suspension Order, the tariff revisions are suspended in part and the entire rate is suspended for one day and the part of the rate that exceeds the rate levels designated in the Virtual Collocation Tariff Suspension Order is suspended for five months to May 15, 1995.
