A3. BASIC LOCAL EXCHANGE SERVICE

A3.1 Exchange Access Lines

A3.1.1 General

- A. Rates for Basic Local Exchange Service are related to the total number of Main Station Lines, Private Branch Exchange Trunks and Centrex Type Services Main Station Lines within the Local Calling Area, including those of other telephone companies within the same Local Calling Area.
- B. The Exchange Service Area for each exchange is identified on maps.
- C. The rates for service and equipment not specifically shown in this section are presented in other sections of this Guidebook.
- D. Individual Residence and Business Main Station Line Service are comprised of serving central office line equipment and all outside plant facilities needed to connect the serving central office with the customer premises at the demarcation point. These facilities are Company-provided and maintained and provide access to and from the Telecommunications Network for Message Toll Service and for local calling.
- E. Effective December 10, 1993, rotary dial service will not be available for new installations. For Area Calling Service¹ subscribers with rotary dial service and inward facilities (connected prior to December 10, 1993), a credit of \$.75 per residence Area Calling Service line or trunk and \$1.50 per Area Calling Service business line or trunk will apply to the rates specified in A3.2.9. Existing rotary dial service and inward facilities for Area Calling Service subscribers may be modified or changed at the current location (with the exception of a change in class of service), but may not be relocated to a different address. Existing Area Calling Service subscribers with rotary dial service and inward facilities who change to a different class of service and Area Calling Service subscribers who connect new lines or trunks will be billed at the rates specified in A103.2.9 (Residence) or A3.2.9 (Business).
- F. Residence Access Line Retention Offer
Existing residential customers who call to disconnect service with AT&T and elect to stay and have one (or up to a maximum of two) access line(s) may be eligible to receive a \$6 per month bill credit for 12 months. The following conditions apply:
 - 1. Customers must keep the required services for 30 days to receive the benefit of this offer.
 - 2. Customers subscribing to Complete Choice Enhanced or Complete Choice Basic must have the access line in service for a minimum of 60 days before the customer becomes eligible for this offer.
 - 3. If the customer disconnects the line(s) or moves from their current location, the remaining benefits will cease.
 - 4. AT&T employees are not eligible for this offer.
 - 5. Customer must be calling into AT&T to disconnect their local service.
 - 6. This offer is available on a maximum of two (2) lines (a maximum monthly reward of \$12).
 - 7. Not stackable with any other regulated retention offer that provides a monthly discount.
 - 8. Eligible customers are existing AT&T residential customers who have a primary access line, or a primary access line with an additional access line(s), and are calling to disconnect one or more access lines.
 - 9. This offer is only available for retention purposes.
 - 10. The monthly bill credit stays in effect as long as the customer remains at the same address and is limited to a maximum of 12 months.
 - 11. Eligible customers may only receive this offer once during the offer benefit period.

- E.** Provided facilities are available and technical equipment allows, extension line service will be furnished in the foreign exchange. The charge quoted in Section A13 for channels for extension line applies for each station.
- F.** The Local Service Rate of, and Long Distance rates to and from, main stations or PBX, Centrex Type Services systems connected for foreign exchange service are the same as regularly apply to stations located in the foreign exchange area.
- G.** Where Foreign Exchange Service is provided at a location outside the exchange area boundary of the exchange from which service is desired and said location is not within the exchange area of another exchange or where the applicant for Foreign Exchange Service is so located that it would be more economical to the Company to provide the Foreign Exchange Service direct from the foreign exchange to applicant's location by the extension or utilization of existing plant, the foreign exchange mileage charge will apply as follows:
For the distance from the applicant's location to the Rate Center of the foreign exchange area from which service is to be furnished a mileage charge as specified in A9.1.3 applies.
- H.** Foreign Exchange Service may be furnished involving two areas of the Company or involving an area of the Company and an area of a connecting company when the connecting company is willing to concur in arrangements for furnishing such service. Where the connecting company provides billing for its portion of the Foreign Exchange Service, the charges will be in accordance with the connecting company's rates, terms and conditions.
- I.** Where alternate full period Foreign Exchange Service is provided, an intercept arrangement may be furnished which transfers the foreign exchange number to a receiving only local number when the service is in the full period condition. This arrangement contemplates a standard termination in a handset, key equipment or PBX and is furnished at the rates and charges as specified in A9.1.3.

A9. FOREIGN EXCHANGE SERVICE AND FOREIGN CENTRAL OFFICE SERVICE

A9.2 Foreign Central Office Service

A9.2.1 General

- A. Foreign Central Office Service is exchange service furnished to a subscriber in a multioffice exchange from a central office other than the one from which service would normally be furnished.
- B. Foreign Central Office Service is offered in connection with Individual Line Main Station Service, PBX Service and Centrex Type Services only.
- C. Other services, equipment or facilities used in connection with Foreign Central Office Service, except as otherwise indicated in this Guidebook, are furnished subject to the rates, terms and conditions applying in the foreign central office from which the subscriber is served.
- D. Alternate routing of this service may be provided on a direct serve basis to the subscriber's premises from the requested foreign central office on an individual case basis as specified in Section A5., subject to the following conditions:
 - 1. The subscriber must maintain a minimum of fifty percent of the trunks/lines from the central office from which service would normally be furnished.
 - 2. Rates and charges for all components of the service will continue to apply as specified in A9.2.2.A. and B. following, except that rates for Type 2145 channels do not apply. The monthly rate for the class of service desired will be that applicable from the foreign central office, however, the rate will be no less than that applicable had the service been provided from the normal serving wire center. Additionally, rates and charges as specified in Section A5. for the construction of facilities from the foreign central office to the subscriber's premises will apply.

A9.2.2 Rates And Charges

A. Methods Of Applying Rates

The rate for Foreign Central Office Service is the monthly rate for the class of service desired, plus a foreign central office mileage charge as shown in A9.2.2.B. following, for the distance, airline measurement, between the central office from which the subscriber would normally be served and the foreign central office, i.e., the central office from which the subscriber desires to be served. In addition, the subscriber is charged any zone charges which would apply for connection with the central office from which service normally would be rendered.
