- 2) Interconnection of Mobile Services (see Section A35)**

**All other services have been deregulated and can now be found in the General Exchange Guidebook.**

Intrastate Communication Services are furnished through facilities provided by the Company for the transmission of intelligence by electrical impulse, principally by means of wire, radio or a combination thereof.

The Company may discontinue certain Company services in geographic areas for which the Company has no customers subscribing to those services. The Company may grandfather Company services in certain geographic areas at its discretion, subject to any applicable regulatory approvals. All services described in this Tariff will no longer be available for purchase by new or existing customers in certain geographic areas in South Carolina. In addition, requests to move, add or change existing service will not be accepted. Existing customers may cancel local features on their existing service.
