Existing term plan customers of PremierSERV Frame Relay Service and PremierSERV ATM Service may add, move, remove or change lines and/or locations for the duration of their current term plan agreement, but may not enter into any new term plan agreements except a new 12 month term for service additions as permitted above. The Company will support one extension of an existing non-expired term plan agreement (other than a new term plan for service additions as provided above) past its current term for twelve (12) months, provided the extension is signed on or before June 30, 2013 and the extension period expires no later than June 30, 2014. Upon expiration of the extension and for existing customers who do not extend an existing non-expired term plan agreement, service will continue on a month-to-month basis at the same rates in effect for such service immediately prior to such expiration, until the service is discontinued on at least 30 days prior notice by the customer or on at least 30 days notice (or such longer period as may be required by the Commission) by the Company. During such month-to-month period, the Company may change the rates, terms and conditions applicable to the customer's service upon at least 30 days written notice to the customer. Effective September 30, 2011, early termination charges shall not apply to any PremierSERVSM Asynchronous Transfer Mode (ATM) and PremierSERVSM Frame Relay services defined in this Section.
