SPECIAL ACCESS SERVICE

7.1 GENERAL

This section concurs in SWBT Tariff FCC No. 73, Section 7, as of August 5, 1998, except for the following:

7.1.1 High Voltage Protection Service

Regulations and charges, as specified in Section 16 of the General Exchange Tariff, apply to Special Access services that extend to electric power generating, switching, and distributing locations that require special high voltage protection equipment.

7.1.2 Cross Boundary Jurisdiction

In those cases where an intraexchange service has stations in Kansas and another state, the service is considered as jurisdictionally intrastate. The application of charges is modified to apply the charges for that portion of the service located in the other state to be pursuant to that state's tariff or guidebook.

7.1.3 Intraexchange Application

Jurisdictionally intraexchange Special Access Service shall not be used for any purposes for which a payment or other consideration, direct or indirect, shall be received by the customer for the collection, transmission, or delivery of any communications for others.

7.1.4 Multipoint Service, Single Wire Center

Multipoint Service provisioned entirely out of the same serving wire center may be bridged in that serving wire center.

7.1.5 Basic Video

Basic Video Service, as described in Southwestern Bell Telephone Company (SWBT) Tariff FCC No. 73, does not apply in the intrastate jurisdiction.

7.1.6 Special Access Surcharge

In the intrastate jurisdiction, the Special Access Surcharge only applies to WATS Access Lines⁽²⁾ (WAL) and does not apply to Metallic⁽²⁾, Telegraph Grade⁽²⁾, Voice Grade⁽²⁾, Program Audio⁽¹⁾, MegaLink[®] Data⁽²⁾ or High Capacity services. (C)

7.1.7 Message Station Equipment Recovery Charge

The Message Station Equipment Recovery Charge does not apply to Special Access services in the intrastate jurisdiction.

7.1.8 Program Audio⁽¹⁾

Daily rates for Program Audio⁽¹⁾ services, as found in SWBT Tariff FCC No. 73, do not apply in the intrastate jurisdiction.
