- (A) This plan is a direct dialed outbound international long distance service offered to residential Customers from switched access lines. Service is offered on a flat rate basis, twenty-four hours per day, seven days per week. Per minute charges apply and will be based on the country called and the duration of the call. Customers must dial 1 plus the country code or area code, if applicable, and the terminating number to complete a call utilizing this service. (C)
- (B) Customers of this plan must also subscribe to BellSouth® Complete Choice® plan, BellSouth® Area Plus® plan, Flat Rate Residential Individual lines, Local Optional Service (available in Louisiana only), Area Calling Plan (available in Mississippi only), or Community Caller Plus (available in North Carolina only). Customers who subscribe to Flat Rate Residential lines, Local Optional Service, Area Calling or Community Caller Plus must also subscribe to at least two Associated Services listed in Section 3.1.9 of this pricing and service guide. These plans and services are provided by the Company's affiliated incumbent local exchange entity.
- (C) All calls are billed in one (1) minute increments after an initial period, for billing purposes, of one (1) minute. This plan is only offered in conjunction with BellSouth® interstate long distance service. Customers who no longer meet the eligibility requirements identified above will be transferred to Residential MTS. The Customer will be billed a minimum monthly commitment charge if actual usage is below the commitment level in any month. Usage over the minimum monthly commitment charge may not be carried over to future months to satisfy the commitment. (C)
- (D) The Minimum Monthly Commitment charge is \$14.95 and the per-minute usage rates are as follows:

Customers must dial 1 plus the area code, if applicable, and the terminating number to complete a call utilizing this service.
- (B) Customers must subscribe to and maintain one of the residential services and Vertical Features Packages as defined and offered by the Affiliated ILEC of the Company. This plan may require at least one (1) or more products or services offered by the Affiliate of the Company as defined and offered by the Affiliate of the Company in conjunction with a subscription to this plan. Customers required to subscribe to one (1) or more products offered by an Affiliate of the Company must continue to subscribe to those products.
- (C) All calls are billed in one (1) minute increments after an initial period, for billing purposes, of one (1) minute. This service is only offered in conjunction with the corresponding intrastate BellSouth® Nickel Value plan. This service is not offered on an intraLATA only basis.
- (D) The MRC is \$7.95 and the per minute usage rate is \$0.0500. This MRC is the same as the MRC identified in the Company's state specific service guides. Only one monthly service charge will apply when both interstate and intrastate service is provided to the Customer.

- (B) Customers of this plan must subscribe to BellSouth<sup>®</sup> Complete Choice<sup>®</sup> plan, BellSouth<sup>®</sup> Area Plus<sup>®</sup> plan, BellSouth<sup>®</sup> PreferredPack<sup>®</sup> plan, Flat Rate Residential Individual lines, Area Calling Plan (available in Mississippi only), Community Caller Plus (available in North Carolina only), Local Optional Service (available in Louisiana only) or 2 Pack. - (C) All calls are billed in one (1) minute increments after an initial period, for billing purposes, of one (1) minute. This service is only offered in conjunction with the corresponding intrastate AT&T Core Value plan. This service is not offered on an intraLATA only basis.
- (D) The MRC is \$4.99 per account and the per minute usage rate is \$0.1200. The MRC is the same as the MRC identified in the Company's state specific tariffs/price lists. Only one monthly service charge will apply when both interstate and intrastate service is provided to the Customer.
