This filing revises Schedule Cal. P.U.C. No. A5. Exchange Services, 5.10 Exchange Boundary Maps, to realign the boundary between AT&T California's Colton and Riverside Exchanges. This proposed transfer of .067 square miles from the Colton Exchange to the Riverside Exchange is desired in order to provide service to a property adjacent to the Riverside Exchange that will soon be developed. Provisioning service from the Riverside Exchange would be the most cost effective to both future customers and AT&T California. There are no existing customers being served in the area being transferred.
