This filing revises Schedule Cal.P.U.C. No. A5. Exchange Services, 5.2 Local Exchange Service, 5.2.5, Local Service Options, 5.2.5, E, Universal Lifeline Telephone Service (California LifeLine), to revise the Specific Support Amount (SSA) credit, the Additional LifeLine Support credit and the Carrier Credit, as needed, to reflect an increase in the Federal End User Common Line (EUCL) charge (also known as the Federal Subscriber Line Charge) that was effective October 1, 2014. The Company implemented these changes on October 1, 2014. The customer's California LifeLine rate remains the same.
