This filing revises Schedule Cal.P.U.C. No. A5. Exchange Services, 5.2 Local Exchange Service, 5.2.5, Local Service Options, 5.2.5, E, Universal Lifeline Telephone Service (California LifeLine), to revise the Specific Support Amount (SSA) credit, the Additional LifeLine Support credit and the Carrier Credit, as needed, to offset an increase in the Federal End User Common Line (EUCL) charge (also known as the Federal Subscriber Line Charge) that is effective July 1, 2015. The customer's California LifeLine rate remains the same. Additionally, this filing corrects a clerical oversight of LifeLine credits for the San Luis Obispo exchange on Sheet 347.10.8. The oversight did not affect customers' LifeLine rates.

In compliance with General Order 96-B, we are serving a copy of this advice letter and related tariff sheets to interested parties who have requested.
