This filing revises Schedule Cal.P.U.C. No. A5. Exchange Services, 5.2 Local Exchange Service, 5.2.5, Local Service Options, 5.2.5, E, Universal Lifeline Telephone Service (California LifeLine), to add a Carrier Credit to California LifeLine service to offset the increase in the Federal End User Common Line (EUCL) charge (also known as the Federal Subscriber Line Charge) that is effective July 1, 2016. The customers' California LifeLine rates remain the same.
