This filing revises Schedule Cal.P.U.C. No. A5. Exchange Services, 5.2 Local Exchange Service, 5.2.5 Universal Lifeline Telephone Service (California LifeLine), to add a Carrier Credit to California LifeLine service to offset the increase in the Federal End User Common Line (EUCL) charge (also known as the Federal Subscriber Line Charge) that is effective July 1, 2017. Customers' California LifeLine rates remain the same.

In compliance with General Order 96-B, we are serving a copy of this advice letter and related tariff sheets to interested parties who have requested.
