This filing revises Schedule Cal.P.U.C. No. A5. Exchange Services, 5.2 Local Exchange Service, 5.2.5 Universal Lifeline Telephone Service (California LifeLine), to increase the Carrier Credit to California LifeLine service from \$0.04 to \$0.05 to offset the \$0.01 increase in the Federal End User Common Line (EUCL) charge (also known as the Federal Subscriber Line Charge) effective October 1, 2017. California LifeLine rates remain the same.
