This filing revises Schedule Cal.P.U.C. No. A5. Exchange Services, 5.2 Local Exchange Service, 5.2.5 Universal Lifeline Telephone Service (California LifeLine), to increase the California LifeLine Carrier Credit from \$0.00 to \$0.11 to offset the \$0.11 increase in the Federal End User Common Line (EUCL) charge (also known as the Federal Subscriber Line Charge) that is effective July 3, 2018. There is no change in the customers' California LifeLine monthly rates.
