This filing revises Schedule Cal.P.U.C. No. A5. Exchange Services, 5.2 Local Exchange Service, 5.2.5 Universal Lifeline Telephone Service (California LifeLine), to decrease the California LifeLine Carrier Credit from \$0.11 to \$0.06 to offset the \$0.05 decrease in the Federal End User Common Line (EUCL) charge (also known as the Federal Subscriber Line Charge) that is effective October 1, 2018. There is no change in the monthly rates for California LifeLine customers.
