Pursuant to General Order 96-B, AT&T California (U-1001-C) submits this Advice Letter to make changes to its intrastate Network and Exchange Services Tariff Schedule Cal. P.U.C. No. A5. The purpose of this filing is to increase per minute rates for residence local usage and ZUM (Zone Usage Measurement) Zones 1, 2, and 3.
