Re: Rebalance Lifeline Credits Due to Change in EUCL

Pursuant to General Order 96-B, AT&T California (U-1001-C) (AT&T) submits this Advice Letter to make changes to its intrastate tariff Schedule Cal.P.U.C. No. A5. Exchange Services, 5.2 Local Exchange Service, 5.2.5 Universal Lifeline Telephone Service (California LifeLine), to increase the California LifeLine Carrier Credit by \$1.02 to offset the \$1.02 increase in the Federal End User Common Line (EUCL) (also known as the Federal Subscriber Line Charge) charge which increased from \$4.89 to \$5.91 effective October 1, 2023. There are no changes in the monthly rates for California LifeLine customers.

This filing will not increase any rate or charge, cause the withdrawal of service, nor conflict with other schedules or rules.

This advice letter is submitted as a Tier I filing in accordance with General Order 96-B. AT&T California requests that this advice letter become effective on October 1, 2023.
