Pursuant to General Order 96-B, AT&T California (U-1001-C) submits this Advice Letter to make changes to its intrastate Network and Exchange Services Tariff Schedule Cal. P.U.C. No. A5, 5.2 Local Exchange Service, 5.2.5 Local Service Options, E. Universal Lifeline Telephone Service (California LifeLine), to modify lifeline credits and increase California LifeLine rates.

This filing will not cause the withdrawal of service or conflict with other schedules or rules.
