The term "Digital City" as it applies to Digital Data Service denotes a city in which a Principal Central Office is located and serves a specific geographic area for Digital Data Service.

DIGITAL CITY RATE CENTER

The term "Digital City Rate Center" for Digital Data Service is a specified geographical location in a Digital City from which mileage measurements are determined for the application of channel mileage rates. This term is synonymous with a "Utility designated hub". See Schedule Cal.P.U.C. No. 175-T, Section 7.4.6 for regulations on Mileage Measurement.

The term "Digital City Serving Area " for Digital Data Service denotes a geographical area served in and around a Digital City.

PRINCIPAL CENTRAL OFFICE

C. 1 X N CONTROL ARRANGEMENT

This arrangement enables the Customer to control up to 48 switching or transfer functions (as described under Transfer and Switching Arrangement) at a Utility Principal Center Office via a remote keyboard terminal capable of either 300 or 1200 bps operations.

Access to the Control Arrangement requires a dial-up data station at the Utility Principal Central Office. The dial-up station is ordered separately from the appropriate tariff and consists of a 212A Dataphone data set and the appropriate Utility provided channel (e.q., local exchange line, CCSA or EPSCS access line).

The Control Arrangement must be located in the same Utility Principal Central Office as the switching or transfer functions which it controls.
