2. General Regulations (Cont'd)2.6 Definitions (Cont'd)Account Owner

Denotes a company, including the Telephone Company, that provides end users with local service, stores and/or administers the end user's information in the Telephone Company's Line Information Data Base (LIDB).

Agent

The term "Agent" denotes that person or persons who have legal authority to give the Telephone Company permission to place public and semi-public pay telephones on their premises, who have the authority to subscribe to the service, and who control access to or usage of the public or semi-public pay telephones.

Aggregator

Denotes any individual, partnership, association, joint-stock company, trust, governmental entity or corporation.

Alternate Billing Service

The term "Alternate Billing Service" (ABS) denotes the ability for end users to make collect calls or bill calls to a third number.

Affiliate

With respect to Expanded Interconnection Service and the collocator, this means any corporation or other entity owning, either directly or indirectly, a majority of the outstanding stock of the collocator ("Parent"), or any corporation or other entity in which a majority of the ownership interest is held, either directly or indirectly, by the Parent or collocator.

6. Switched Access Service (Cont'd)6.2 Provision and Description of Switched Access Service (Cont'd)6.2.5 Line Information Data Base (LIDB) Service(A) General Description

LIDB Service is provided by the Telephone Company to its customers in support of alternate billing services. There are three different LIDB Services offered: LIDB Billing Validation, Originating Line Number Screening Service and Equipment Indicator Service (OLNS Service), and Preferred Validation Service. LIDB Service provides access to billing validation data which resides in the Telephone Company data base for use with alternate billing services, such as Collect (D) Calls and Third Number Billing. OLNS Service provides information on the type of service/equipment associated with the line originating the call. Preferred Validation Service provides for the ability to have the Telephone Company restrict LIDB information from a customers' query-originating service platforms.

Customers participating in LIDB Service for purposes of obtaining LIDB Billing Validation or OLNS Service data originate queries to the LIDB from an Operator Service System (OSS) identified by an originating point code. The requested billing validation data, in the form of signaling information, is passed back from the Service Control Point (SCP) where the LIDB resides via the Telephone Company STP to the customer's designated OSS where the LIDB query originated. The LIDB system will receive and respond to American National Standards Institute Signaling System 7 protocol queries as defined in Bellcore publication TR-TSV-000905, and Pacific Bell publication PUB L-780023 PB/NB.

LIDB Billing Validation Service will provide the following functions on a per query basis:

- Determination of whether the billed line automatically rejects certain calls billed as collect or third number.
- Determination of whether the billed line is a public telephone number using the "Service or Equipment Indicator" in the LIDB.

36. True IP To PSTN (TIPToP) Service (Cont'd)36.1 Service Description (Cont'd)(B) Service Provisioning (Cont'd)(2) Limitations

- (a) Due to technical limitations, two-way port interfaces cannot subtend the following Telephone Company Access Tandems:

ANHMCA0295T, GRDNCA0386T, LSANCA0470T,  
OKLDCA0349T, SHOKCA0589T, SNFCCA2143T, SNDGCA0291T  
and SNTCCA0148T

The TIPToP Customer must select another tandem that meets the LATA Wide TIPToP architecture requirement, as described herein.

- (b) TIPToP service does not include Alternate Billed Services (ABS). ABS includes, but is not limited to, Collect Calling, Third Party Billed Calls, Phone Card calls or Credit Card calls billed to telephone numbers assigned to the IP-VIS User of the TIPToP Customer or the TIPToP Customer. (D)
- (c) Specific to traffic sent to a TIPToP Customer over the TIPToP port interface, TIPToP Service is not available where the Telephone Company is required to pay reciprocal compensation, access charges, meet point billing charges, transit charges, or any other fees.

(3) Emergency 911 Service

Emergency 911 Service is not available with TIPToP Service purchased under this tariff.

(4) SPNP Service Charge

When the TIPToP Customer purchases a TIPToP One-Way Port Interface the Telephone Company will provide Service Provider Number Portability (SPNP) Query Service under the rates and terms as set forth in Section 13.3.16.
