Limited Service Relief Area

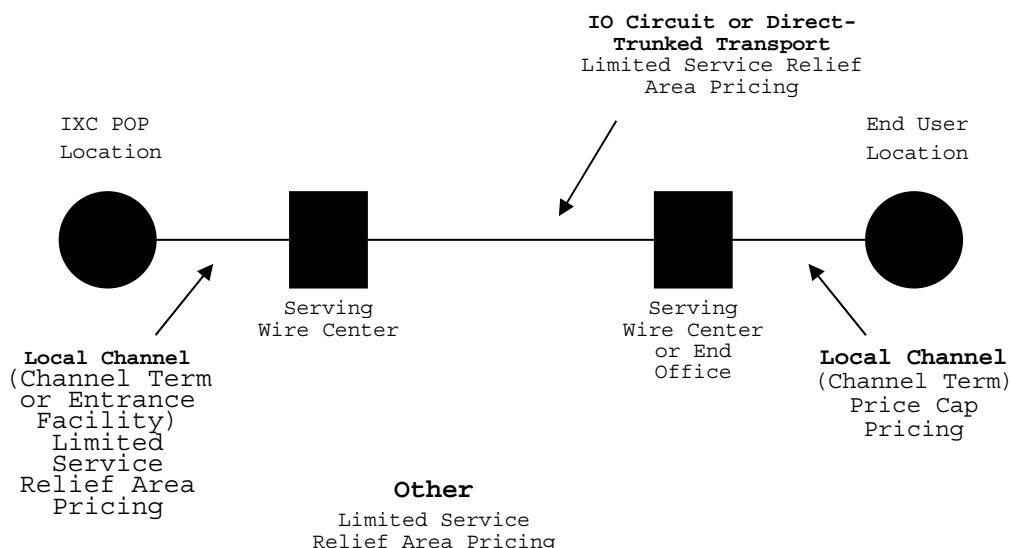

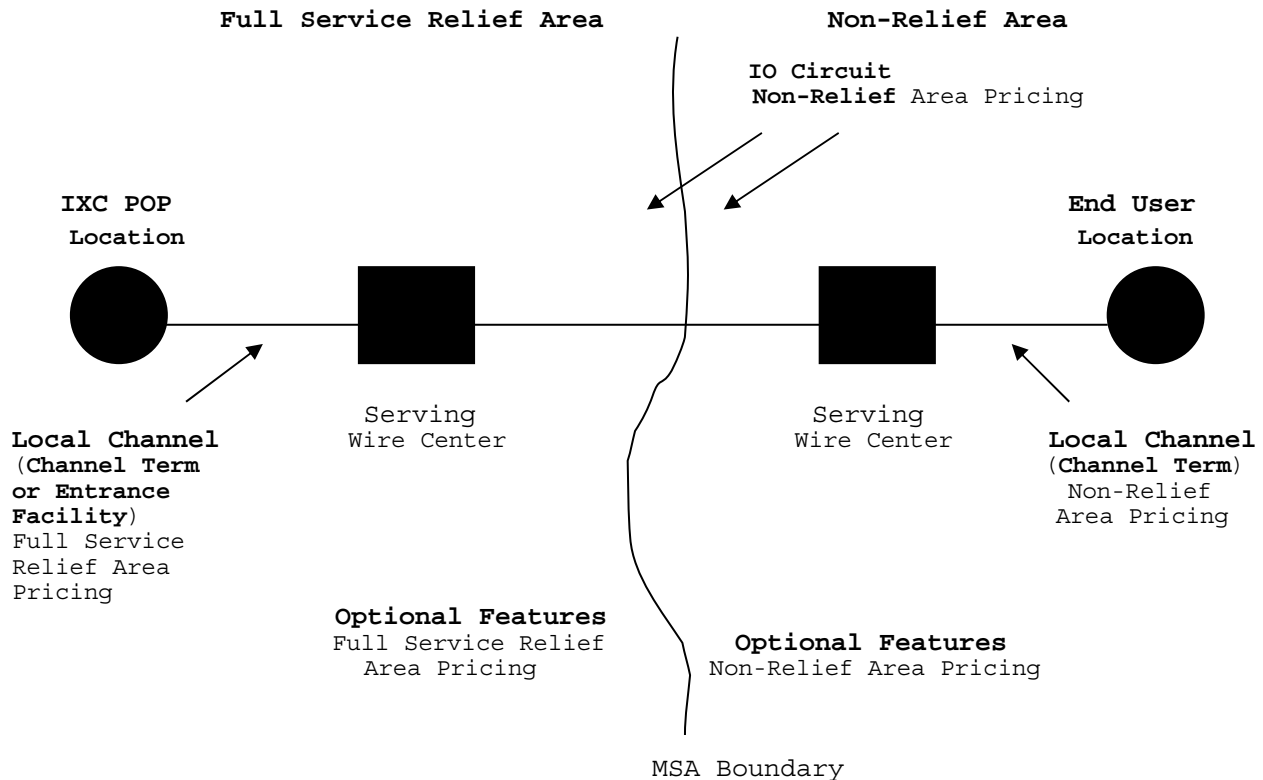

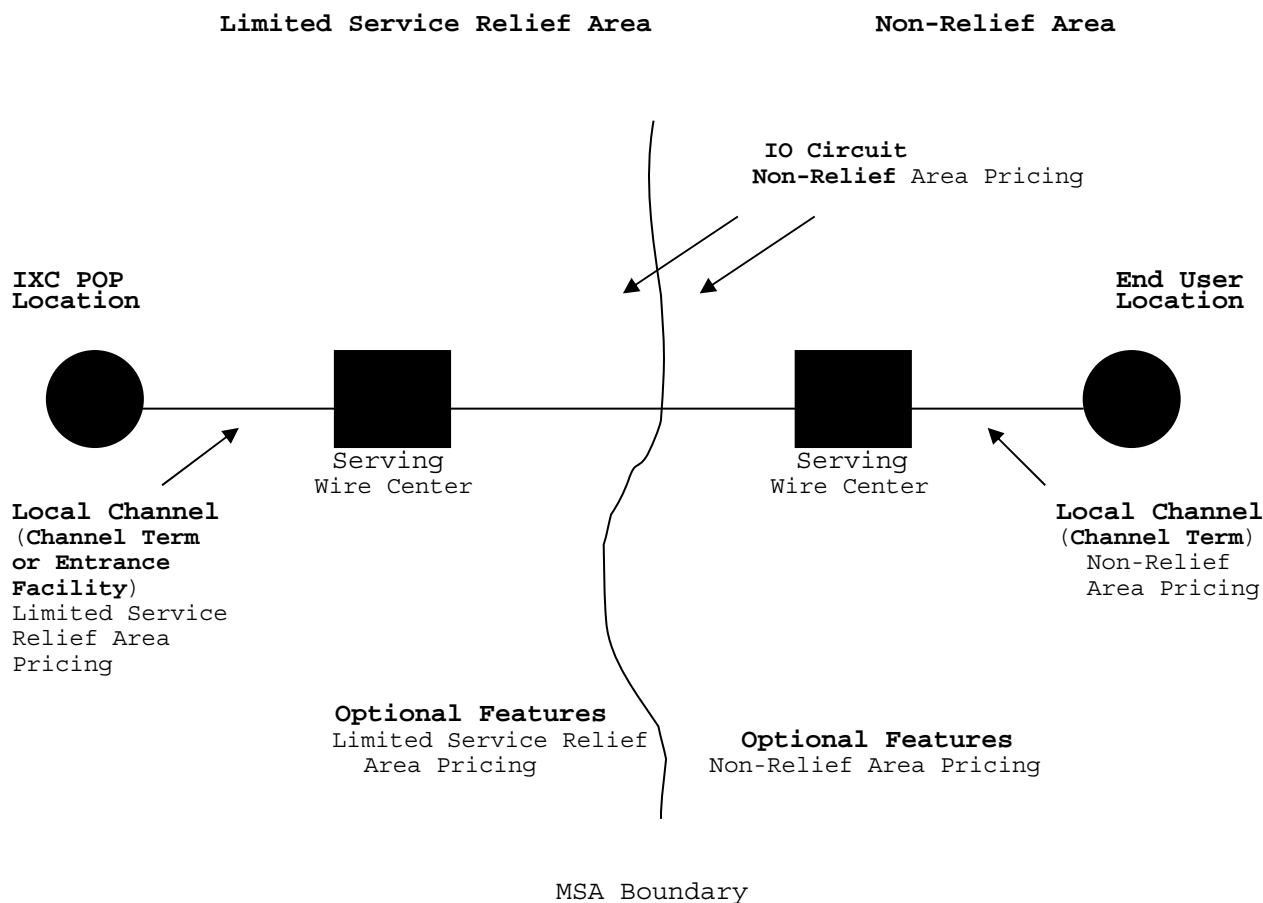
