25. Expanded Interconnection25.1 General Description

Expanded Interconnection provides interconnection between certain Telephone Company-provided interstate access services and the facilities of an interconnector. Expanded Interconnection is available in the collocation arrangements described herein. The Telephone Company will also provide Expanded Interconnection to interconnect with microwave facilities on an individual case basis (ICB) as set forth in 25.3 (Microwave Transmission Facilities). All optical interconnections within a SWBT Central Office will only support single mode fiber termination.

The Telephone Company will provide Expanded Interconnection to the following types of Telephone Company-provided interstate access services:

- Switched Transport (DS1- and DS3- level Entrance Facilities and Direct-Trunked Transport)
- Directory Transport (DS1- and DS3-level Entrance Facilities and Direct-Trunked Transport)
- High Capacity Service (1.544 Mbps)
- MegaLink Custom Service (44.736 Mbps)
- Broadband Circuit Service (155 and 622 Mbps)\*
- Self-Healing Transport Network (44.736 Mbps, 155 and 622 Mbps)
- ReliaNet (44.736 Mbps, 155 and 622 Mbps)
- Dedicated SONET Ring Service (OC-3, OC-12, and OC-48)
- Optical Carrier Network (OCN) Point-to-Point Service
- GigaMAN<sup>®</sup> 1 Gigabit Ethernet
- AT&T Switched Ethernet Service<sup>SM</sup> 1 Gigabit Ethernet
- OPT-E-MAN<sup>®</sup> 1 Gigabit Ethernet
- OPT-E-MAN<sup>®</sup> 1 Gigabit Ethernet
- Customized Switched Metro Ethernet Service (CMSE) 1 Gigabit Ethernet
- WaveMAN<sup>SM</sup> (OC-48 and OC-192)
- AT&T Switched Ethernet Service<sup>SM</sup> 10 Gigabit Ethernet
- AT&T Dedicated Ethernet Service (1, 2.5, 10, 40 and 100 Gigabit Ethernet) (N)
- DecaMAN<sup>®</sup> (10 Gigabit Ethernet) (N)

Expanded Interconnection provided as virtual collocation can also be provided to other Telephone Company-provided interstate Switched Access and Special Access services upon bona fide request as set forth in 25.2 (Virtual Collocation).

Regulations contained in Sections 2 and 5 of this tariff that apply to customers also apply to interconnectors. A description of the rate categories applicable to Expanded Interconnection, how those rate categories are applied and other specific recurring and nonrecurring charges that may also apply are contained in 25.5 and 25.7 (Rate Regulations for Virtual Collocation and Interconnection Cross Connects).

Expanded Interconnection is available at Telephone Company wire centers as specified in the National Exchange Carrier Association, Inc., Tariff F.C.C. No. 4.
