Mobile End Office Connection

Denotes a connection provided between a Mobile Carrier's Mobile Telephone Switching Office and a Telephone Company end office using mobile radio services provided in the Telephone Company's intrastate tariffs. Mobile End Office Connections provide Mobile Carrier's with access to the public switched network of the Telephone Company. Type 1 Connections are a form of Mobile End Office Connections.

Mobile Telephone Switching Office

Denotes a Mobile Carrier's switching system that is used to terminate mobile stations for the purposes of interconnection to each other and to trunks interfacing with the Telephone Company's public switched network.

Multicast Traffic

Ethernet frames that are forwarded to multiple destinations that are identified using a multicast group address.

Multipoint Service

Denotes the connection of three or more customer designated premises through a Telephone Company Hub.

Denotes the network of a carrier that is delivering a call to the Telephone Company's switch and is responsible for determining the status and Location Routing Number of the dialed NXX.

Network Access Point (NAP)

Denotes the point at which a particular STN Digital Transmission Link (DTL) may be interconnected with a Premises Access Node or with High Capacity Service or MegaLink Custom Services in a CO Access Node. Network Control Signaling

7.2 Rate Regulations

Rates and charges for Special Access Service are set forth in Section 7.3 following, with the exception of the services provided by the Telephone Company in the Metropolitan Statistical Areas (MSAs) in which the Telephone Company has received Phase II pricing flexibility pursuant to Subpart H of Part 69 of the Commission's Rules. The rates and charges for the Special Access Services in the MSAs that have received Phase II pricing flexibility are set forth in Section 39.

Jurisdictional proration of rates and charges is set forth in 2.4 (Jurisdictional Report Requirements). Where Access Services are jointly-provided, additional regulations are set forth in 2.6 (Jointly Provided Access Service).

Effective November 1, 2017, Competitive Counties and Non-Competitive Counties have been established and are defined in Section 2.7 and the wire centers within such counties are listed in Sections 15.2(C) and (D).

The Service Establishment charge applies per customer database setup. The customer database setup is a grid, built by the Telephone Company, that contains all the circuits the customer will be able to control and reconfigure. Security, as well as circuit inventory, is built into the grid, permitting the customer control of its own circuits. Also included is the provisioning of customer training. This charge includes the connection of the initial circuits.

(2) Database Modification Charge

This charge applies (per customer contact, or request) each time the customer requests a subsequent modification of its database. A modification can be an addition or deletion of circuits terminating on the cross-connect system, or a rearrangement of the database, e.g., an outside move, a change in the signaling characteristics of a circuit (e.g., from data to voice), a rearrangement of the customer's routing priority between nodes, virtual port establishment, etc.

If the Telephone Company initiates rate changes resulting in a decrease of rates for an existing service with a 3 or 5 year billing period, those rate changes will be passed along to the customer. Rate changes resulting in an increase of rates for an existing 3 or 5 year billing period will not exceed the original rate for that selected bill period. Rate changes may occur as a result of F.C.C. action.

Other Access Services used in conjunction with STN are governed by specific regulations and applicable rates and charges set forth in other sections of this tariff unless otherwise noted herein.

19.3.1 Rate Categories

There are five basic rate categories which apply to STN. There are three rate categories that apply on a DTL Volume Option basis. These rate categories may not be intermixed between different Volume Options on a particular STN. Two rate categories apply to STN, independent of the DTL Volume Option selected by the customer.

Rates and charges (both monthly and nonrecurring) for Kansas MegaLink Custom Services (identified as Nonzoned) will be applied as contained in 20.5. Rates and charges for Arkansas, Missouri, Oklahoma and Texas will be applied based on Pricing Zones as contained in 20.5. The Pricing Zone for each serving wire center is as specified in the National Exchange Carrier Association, Inc. Tariff F.C.C. No. 4. Additionally, if the Channel Mileage crosses Pricing Zones (e.g., serving wire center 1 is in Pricing Zone 1 and serving wire center 2 is in Pricing Zone 2), the higher priced mileage rate will be applied to the entire channel mileage.

For all rate elements other than End User channel terminations and their optional features,⁽⁴⁾ price flex rates and charges, as provided in Section 39.5.2, apply, regardless of whether the county is Competitive or Non-Competitive.

For End User channel terminations and their optional features,^{(3) (4)} the application of "price cap" or "price flex" is dependent upon whether or not the serving wire center is located in a Competitive County. If the End User channel termination is in a Competitive County, price flex rates and charges apply, as provided in Section 39.5.2. If the End User channel termination is in a Non-Competitive County, price cap rates and charges apply, as provided in Sections 7.3 and 20.5. (N)

MegaLink Custom Services offer Portability for any existing term priced service provided each of the following conditions are met:

- (a) Service to be moved is either a 5 year⁽²⁾ or 10 year⁽¹⁾ Billing Period.
- (b) Customer must begin a new Billing Period (5 years or greater)⁽¹⁾⁽²⁾ for the service to be moved and the monthly revenue must be equal to or greater than that of the service in original location.
- (c) New service location is within the same state (i.e. Arkansas, Kansas, Missouri, Oklahoma or Texas) as the original service.
- (d) Facilities and equipment are available in the desired new location.

This section contains specific regulations governing the rates and charges for ReliaNet.

Effective November 1, 2017, Competitive Counties and Non-Competitive Counties have been established and are defined in Section 2.7 and the wire centers within such counties are listed in Sections 15.2(C) and (D). (N)

For all rate elements in Section 31.3, price flex rates and charges, as provided in Section 39.5.2, apply, subject to service availability,⁽¹⁾ regardless of whether the county is Competitive or Non-Competitive. (N)

If the Telephone Company initiates rate changes resulting in a decrease of rates, for an existing service with a 1, 3, 4 or 5 year minimum period, those rate changes will be passed along to the customer. Rate changes resulting in an increase of rates for an existing 1, 3, 4 or 5 year billing period will not exceed the original rate for that selected bill period. Rate changes may occur as a result of F.C.C. action.

Other Access Services used in conjunction with ReliaNet are governed by specific regulations and applicable rates and charges set forth in other sections of this tariff unless otherwise noted herein.

Customers of MegaLink Custom (DS3) Service ordered from Section 20 of this tariff may move DS3 services over to ReliaNet SVOs without termination liability provided conditions are met as set forth in 20.4.6. Provisions for this move are provided in Section 31.3.2(M) following. Customers of High Capacity Service (including OPP and HC-TPP pricing plans) may also move High Capacity (DS1) services to ReliaNet SVOs as set forth in Section 31.3.2(M) following.

39. Metropolitan Statistical Area Access Services39.1 General Description

(A) This section of the tariff provides the regulations, rates and, terms and conditions that apply to telecommunications services provided by the Telephone Company in the Metropolitan Statistical Areas (MSAs) in which the Telephone Company has received Phase II pricing flexibility pursuant to Subpart H of Part 69 of the Commission's Rules. MSAs are divided into the categories below:

(1) Full Service MSAs

Full Service Relief MSAs are those MSAs which qualified for Phase II pricing flexibility for all elements of service, i.e., local channels (channel terminations) between LEC end offices and customer (end user) premises; entrance facilities; dedicated interoffice facilities; local channels (channel terminations) between an interexchange carrier's point of presence and a serving wire center. The Full Service Relief MSAs are set forth in Section 39.2(A), following.

(2) Limited Service MSAs

Limited Service Relief MSAs are those MSAs that qualified for Phase II pricing flexibility for all elements of service except local channels (channel terminations) between a LEC end office and a customer (end user) premise. The Limited Service Relief MSAs are set forth in Section 39.2(B), following.

(B) The services provided in MSAs pursuant to this section of the tariff are set forth in Section 39.3 following. These services are comparable to the SWA Dedicated Transport Services in Sections 6.9.2(A) (1), 6.9.2(A) (3), 6.9.2(B) (1), 6.9.2(B) (3), 6.9.2(B) (4), 6.9.2(F), 6.9.2(G) and the Special Access Services in Sections 7, 18, 19, 20, and 31. The general regulations, service descriptions and rate regulations for the SWA Dedicated Transport Services in Section 6 and the Special Access Services in Sections 7, 18, 19, 20, 31 and 35 are also applicable to the services specified in this section, except as provided below. (D)

An exception in 39.4(F) applies for term pricing plans.

(C) Unless otherwise provided for in this section, regulations set forth in Sections 1, 2, 5, 13 and 15 are also applicable. (C)
