13.3.8 International Blocking (Cont'd)

The nonrecurring charge for International Blocking applies on a per line basis and is assessed only when the service is requested subsequent to the installation of the line side Switched Access or exchange service.

13.3.9 Billing Name and Address Service

(A) General Description

Billing Name and Address (BNA) Service is provided by the Telephone Company to interstate service providers. BNA Service provides the customer with billing name and address information of an end user in the Telephone Company's billing records. BNA Service is not to be used for purposes other than for billing and collecting the amount due for telecommunication services from the Telephone Company's end user.

The service allows for a customer to submit the end user's ten-digit Automatic Number Identification (ANI) to the Telephone Company mechanically. Mechanized input for BNA Service is provided through electronic data (C) transmission. The Telephone Company, upon receipt of the customer's request, will process the ANI. If the BNA information is available within the Telephone Company's billing records, the Telephone Company will produce a mechanized report of the associated BNA information in either paper or electronic data (C) transmission media.
