17. Term Pricing Plan Vintage Rates17.1 Rates and Charges

17.1.1 General Regulations

Term Pricing Plan vintage rates are those rates that apply to existing services provided under a term pricing plan in the event the Telephone Company initiates a rate increase. Vintage rates as set forth following are classified as vintage because the Telephone Company ensures that rates provided under a term pricing plan will not be increased by the Telephone Company, above the term pricing plan rate in effect at the beginning of the customer's term pricing plan.

Customers under their current term pricing plans will continue to pay the rates as shown in the original sections until such time as:

- the effective tariff rate in the original section becomes lower than the vintage rate, or
- the customer's existing term pricing plan expires, or
- the service is terminated by the customer.

In addition, other customer modifications, other than termination, that cause a new rate or term pricing plan to be established will result in the service becoming non-vintage and the rates as specified in the original sections will apply.
