

ACCESS SERVICE**10. Federal Government Specialized Service or Arrangements****10.1 General**

This section covers Specialized Service or Arrangements that are provided to a customer for use only by agencies or branches of the Federal Government and other users authorized by the Federal Government. In addition, this section covers TSP procedures as set forth in this section and as administrated by the Federal Government. Services provided to state emergency operations centers are included. These services provide for command and control communications, including communications for national security, emergency preparedness and presidential requirements. They are required to assure continuity of Government in emergency and crisis situations and to provide for national security.

Services for command and control communications and for national security and emergency preparedness sometimes require short notice and short duration service provisions. These provisions are especially needed to meet presidential requirements or in response to natural, man-made, or declared emergencies. Requirements of this type cannot be forecasted and are usually needed for a relatively short period. The provision of service under these conditions may require the availability of facilities, such as portable microwave equipment, which are provided on a temporary basis by the Telephone Company or customer.

10.2 Emergency Conditions

These services will be provided on the date requested or as soon as possible thereafter when the emergency falls into one of the following categories:

- State of crisis declared by the National Command Authorities (includes commitments made to the National Communications System in the "National Plan for Emergencies and Major Disasters").
- Efforts to protect endangered U.S. personnel or property both in the U.S. and abroad. (Includes space vehicle recovery and protection efforts.)
- Communications requirements resulting from hostile action, a major disaster or a major civil disturbance.
- The director (Cabinet level) of a Federal department, Commander of a Unified/Specified Command, or head of a military department has certified that a communications requirement is so critical to the protection of life and property or to the National Defense that it must be processed immediately.

- Political unrest in foreign countries which affect the national interest.
- Presidential service.

10.3 Intervals to Provide Service

Certain services provided under the provisions of this section of the tariff are provided on an individual case basis. Therefore, orders for such service shall be placed under the Negotiated Interval provisions set forth in 5.2.1(B) preceding.

10.4 Safeguarding of Service

10.4.1 Facility Availability

In order to insure communications during periods of emergency, the Telephone Company will, within the limits of good management, make available the necessary facilities to restore service in the event of damage or to provide temporary emergency service, as set forth in Sections 10.6.1(D) and 10.6.3(E), following In order to meet the requirements of agencies or branches of the Federal Government, the Telephone Company may utilize government-owned facilities, when necessary to provide service.

10.5 Federal Government Regulations

In accordance with Federal Government Regulations, all service provided to the Federal Government will be billed in arrears. However, this provision does not apply to other customers that obtain services under the provisions of this tariff to provide their services to the Federal Government.

10.6 Service Offerings

The following unique services are provided to a customer for use only by agencies or branches of the Federal Government, other authorized users and state emergency operations centers. The rates and charges for certain services shall be developed on an individual case basis and shall be consistent with the rates and charges for services offered in other sections of this tariff.

Approximate bandwidth of 10-50,000 Hertz. Furnished for two-point secure communications on two-wire or four-wire metallic facilities between an IC premises and an end user's premises. Services are conditioned as follows:

T-3 Conditioning - The absolute loss (referenced to 1 milliwatt) with respect to frequency shall not exceed:

15 dB	at	10 Hz
13 dB	at	100 Hz
9 dB	at	1,000 Hz
20 dB	at	10,000 Hz
30 dB	at	50,000 Hz

Additional conditioning (available in one or two directions on four-wire facilities only) to provide the following characteristics:

The absolute loss (referenced to one milliwatt) with respect to frequency shall not exceed:

0 dB at 1,000 Hz
+ 1dB between 1,000 Hz and 40,000 Hz
+ 2dB between 10 Hz and 50,000 Hz
(+ means more loss)

The net loss of the conditioned service (with or without additional conditioning) shall not vary by more than four dB at 1,000 Hz from the levels specified above. Voice frequency signaling or supervisory tones can be transmitted.

(2) Voice Grade Secure Communications Type II

Approximate bandwidth 10-50,000 Hz. Furnished on four-wire metallic facilities for duplex operation for two-point secure communications between an IC premises on an end user's premises and an end user's premises. Services are conditioned as follows:

G-1 Conditioning - The absolute loss with respect to frequency and the net loss variation shall be the same as Voice Grade Secure Communications Type I services without additional conditioning. Voice frequency signaling or supervisory tones can be transmitted.

(3) Voice Grade Secure Communications Type III

Approximate bandwidth 10-50,000 Hz. Furnished on four-wire metallic facilities for duplex operation for two-point secure communications between an IC premises switch and an end user's premises. Services are conditioned as follows:

G-2 Conditioning - The absolute loss with respect to frequency and the net loss variation from the switch to an end user's premises shall be the same as Voice Grade Secure Communications Type I services without additional conditioning; from an end user's premises to the switch shall be the same as Voice Grade Secure Communications Type I services with additional conditioning. Voice frequency signaling or supervisory tones can be transmitted.

(4) Voice Grade Secure Communications Type IV

Approximate bandwidth 10-50,000 Hz. Furnished on four-wire metallic facilities for duplex operation for two-point secure communication between two IC premises switches. Services are conditioned as follows:

G-3 Conditioning - The absolute loss with respect to frequency and the net loss variation shall be the same in both directions of transmission as Voice Grade Secure Communications Type I services with additional conditioning. Voice frequency signaling or supervisory tones can be transmitted.

Service arrangements for secured communications to accommodate the transmission of binary digital baseband signals in a random polar format.

(1) Wideband Secure Communications Type I

For transmission at the rate of 18,750 bits per second.

(2) Wideband Secure Communications Type II

For transmission at the rate of 50,000 bits per second.

(3) Wideband Secure Communications Type III

To accommodate the transmission of restored polar two-level facsimile signals with a minimum signal element width of twenty microseconds at a rate of 50,000 bits per second.

To accommodate the transmission of binary digital baseband signals in a random polar format at the rate of 50,000 bits per second.

(C) Special Routing Access Service

Special Routing Access Service is furnished only to AT&T Communications (AT&T-C) for an agency or branch of the Federal Government. This service provides the customer's end users the ability to originate and terminate calls to or from the customer's premises utilizing a Special Routing Plan. This service is an optional service which operates in conjunction with Trunk Side Premium Access Service furnished to AT&T-C under other provisions of this tariff.

The Telephone Company will record Special Routing Access Service Active Mode Trunk Usage, and will bill the customer in accordance with these records. The hours for each trunk ordered will be summed and then rounded to the nearest hour, except that when the total is less than one hour, one hour will be used to determine the charge.

Wideband Service is limited to circuits in place as of August 11, 1988.

- (1) Priority installation and/or restoration of NSEP telecommunications services shall be provided in accordance with Part 64.401, Appendix A, of the Federal Communications Commission's (FCC's) Rules and Regulations.

In addition, TSP System service shall be provided in accordance with the guidelines set forth in "Telecommunications Service Priority (TSP) System for National Security Emergency Preparedness (NSEP) Service Vendor Handbook" (NCS) Handbook 3-1-2 dated July 9, 1990, and "TSP System for National Security Emergency Preparedness (NSEP) Service User Manual (NCS) M 3-1-1.

The TSP System is a service, developed to meet the requirements of the Federal Government as detailed in Service Vendor's Handbook, and Service User Manual which provides the regulatory, administrative and operational framework for the priority installation and/or restoration of (NSEP) telecommunications services. These include both Switched and Special Access Services. The TSP System applies only to NSEP telecommunications services, and requires and authorizes priority action by the Telephone Company providing such services. TSP System applicability is limited to Access Services which the Telephone Company can discreetly identify for Priority Installation and/or Priority Restoration.

- (2) Some of the elements required for the TSP System are included in other sections of this tariff as general service offerings. They have been referenced in this section to reflect the complete TSP System with appropriate references to those other sections of the tariff for regulations, rates and charges.
- (3) The customer for TSP System Service also must be the same customer for Access Service with which it is associated.

(D) Telecommunications Service Priority (TSP) System (Cont'd)

- (4) Under certain conditions it may be necessary to preempt one or more customer services with a lower or no restoration priority in order to install or restore NSEP telecommunications service(s) of a higher priority. If such preemption is necessary, and if circumstances permit, the Telephone Company will make reasonable effort to notify the preempted service customer of the action to be taken. Credit allowance for such service preemption shall be made in accordance with the provisions set forth in 2.4.4(E) preceding concerning Temporary Surrender of a service.
- (5) The customer, in obtaining TSP System service, acknowledges and consents to the provision of certain customer service record information by the Telephone Company to the Federal Government as denoted in The TSP Service Vendor Handbook in order for the Government to maintain and administer its overall TSP System. This customer service record information will include only TSP Authorization Code and Telephone Company Circuit/Service ID.
- (6) When Priority Restoration Maintenance and Administration, as defined in the TSP Service Vendor Handbook, is discontinued (Revocation of Assigned Restoration Priority), and the associated Access Service is continued in service, the charge specified in 10.6.3(E)(2)(c) will not apply for such a discontinuance.
- (7) Credit allowance for service interruption for Priority Restoration Maintenance and Administration shall be the same as for the Access Service with which it is associated as set forth in 2.4.4 preceding.
- (8) Certain activities performed by the Telephone Company associated with the TSP System, as specified in the Service Vendor Handbook, are included in the rate elements as follows:

 - (a) Priority Installation Invocation includes System Development, Verification Confirmation and Preemption.

(8) (Cont'd)

- (b)** Priority Restoration Level Implementation includes System Development, Verification and Confirmation.
- (c)** Priority Restoration Level Change includes Verification and Confirmation.
- (d)** Priority Restoration Maintenance and Administration includes Reconciliation and Preemption.

- (9)** The regulations in 13.2 following for Additional Labor and/or Engineering not withstanding, when performing Priority Restoration (Repair) and/or Priority Installation of an Access Service the Telephone Company will attempt but, due to circumstances beyond its control, may not be able to notify the customer when Additional Labor charges, as set forth in 13.2.6 following, apply before the required Additional Labor is undertaken. In obtaining a Restoration Priority, the customer recognizes that quoting charges for Additional Labor and obtaining permission to proceed with the restoration of certain Access Services will cause unnecessary delays and, therefore, would be contrary to the aforementioned Rules and Regulations.

In subscribing to Restoration Priority and/or Priority Installation service the customer recognizes this condition and grants the Telephone Company the right to quote charges after the restoration has been completed.

- (10)** The existing Restoration Priority (RP) System, as delineated in Section 13.3.2, following, will be transitioned to the TSP System over a 30 month period beginning September 10, 1990. Both systems will be in effect during the transition period. Customers have the entire period to make the transition from RP certifications to TSP arrangements. No new RP assignments will be permitted after September 10, 1990. All RP certifications not already transitioned to TSP will be cancelled at the end of the transition period.

(E) Federal Government Term Discount Plan (FGTDP)*

(1) General

(a) The Federal Government Term Discount Plan (FGTDP) will be provided to any customer awarded a contract to provide telecommunications services for the exclusive use of the Federal Government and its authorized agents. The FGTDP will allow each of the Federal Government's authorized contractors providing network services under contract to obtain discounted rates for specified services in return for certain term commitments.

(b) In addition to the specific terms and conditions of this Plan described below, all other General Regulations for this Plan are contained in Sections 1, 2, and 5 preceding.

(2) Service Component Limitation

This Plan is limited to Direct Analog, DS1 and DS3 service offerings as described in Section 7, preceding.

(E) Federal Government Term Discount Plan (FGTDP) (Cont'd)*

(3) Terms and Conditions

- (a) This plan will apply rate discounts, as specified in 10.6.1(E)(4) following, for Direct Analog, DS1 and DS3 Local Distribution Channels, Channel Mileage Terminations and Channel Mileage recurring rate elements from specific government locations (Service Delivery Points). Nonrecurring charges will apply for all installations, changes and additions/deletions of circuits and optional features and functions according to the rates in effect as specified in other sections of this tariff.
- (b) In the case where the government agency(s) at a current SDP chooses or is ordered to move to a new SDP, and the new SDP requires the same or more services provided under the plan, termination liabilities will not apply. Services at the new SDP will require a new term commitment to receive a discount.
- (c) If, as a result of a Federal Government mandated major site (i.e., Air Force base, Naval or Army installation, etc.) closing, any services provided under the FGTDP are discontinued, termination liabilities will not apply.
- (d) DS1 and DS3 services receiving term discounts under this plan are excluded from any application of Shared Use provisions in Section 7.4.9 preceding.
- (e) Should the customer wish to increase the term of service currently under the plan, they may suspend the shorter term and establish the longer term. Should the customer wish to decrease the term of service currently under the plan, they may cancel the longer term and establish a new shorter term. However, on the canceled longer term service, the customer will be billed termination liabilities based on the dollar difference between the longer term and the shorter term for each month the service was provided.

(3) Terms and Conditions (Cont'd)

- (f) Except as specified in (c) preceding, customers requesting termination of service prior to the expiration date of the plan term will be liable for a termination charge. The termination charge will be the dollar difference between what the customer paid under the plan and the rates that the customer would have paid absent the plan.

(4) Plan Discounts

(a) Direct Analog

The following plan discounts will be applied each month to prevailing Direct Analog service monthly rates as specified in Section 7.5.3 preceding:

60 Months	5 percent

(b) DS1 and DS3

Discounted rates for 12 month, 24 month, 36 month, 48 month and 60 month DS1 and DS3 service term commitments will be applied each month to the prevailing DS1 and DS3 rates as specified in Section 7.5.9 preceding and will be the dollar difference between the rate applicable for the service within the rate zone normally assigned to the customer's serving wire center, as specified in Section 7.4.1 preceding, and the next lower rate zone.

At the expiration of the FGTDP term the customer may select a new FGTDP term at the prevailing FGTDP rate or convert to a month to month rate. Customers completing an FGTDP term that converts to a month to month rate will continue to receive the rate zone upgrade for the month to month service.

(F) SBC Federal Access Solution Transport (FAST) Program

(1) General Description

This section contains regulations, rates and charges applicable to the provision of SBC FAST Program to any customer awarded a contract to provide telecommunications services for the exclusive use of the Federal Government, Agencies of the Federal Government, or authorized agents of the Federal Governments. The SBC FAST Program will allow each of the Federal Government's authorized contractors providing network services under contract to obtain discounted rates for specified services in return for certain term commitments for dedicated Special Access connections to government locations.

(2) Services Available Under SBC FAST Program

SBC FAST Program is provided as a monthly service arrangement with a 3 year service period for the following services listed below:

(3) Limitations

- (a) For Services ordered under SBC FAST Program, the following charges will be waived for new installation:

- (1) DS1 Design and Central Office Connection Charge
- (2) DS1 Customer Connection Charge
- (3) DS3 Design and Central Office Connection Charge
- (4) DS3 Customer Connection Charge

However the nonrecurring charges will apply pursuant to the DS1 or DS3 moves, Section 10.6.1, (F)(5), following.

- (b) All other nonrecurring charges will apply including the administrative charge.
- (c) When a rate element is ordered under the SBC FAST Program, that rate element may not be used for non-SBC FAST Program services. Rate elements not included in this plan as specified in Section 10.6.1(F)(7) are not available under SBC FAST Program and must be purchased from the appropriate tariff section.
- (d) During the term of the selected SBC FAST Program, Telephone Company initiated recurring rate changes (increases or decreases) will automatically be applied to the monthly charges for the remaining months of the current SBC FAST Program term.
- (e) The monthly recurring rate during the SBC FAST Program term will never exceed the rate in effect at the beginning of the customer SBC Fast Program term.
- (f) The SBC FAST Program cannot be combined with any other tariffed services, discounts, or pricing flexibility contracts, unless explicitly stated in the respective tariff terms and conditions.
- (g) Services receiving term discounts under this plan are excluded from any application of Shared Use provisions in Section 7.4.9 preceding.

(F) SBC Federal Access Solution Transport (FAST) Program (Cont'd)

(4) Conversions and Upgrades

(a) Conversions of FGTD Service to a new SBC FAST Program

Conversions from FGTD Service to a new 3-year SBC FAST Program term may be made if the expiration date for the new 3-year SBC FAST Program term is beyond the expiration of the original FGTD service being converted and will become effective upon completion of the conversion activity. The rates, terms, and conditions applicable for the new 3-year SBC FAST Program term will be those in effect at the time the conversion is completed. Administrative Charges will apply for conversions of existing FGTD Service to a new 3-year SBC FAST Program term.

(b) Conversions of existing SBC FAST Program services to a different SBC FAST Program term

At any time prior to the expiration of the SBC FAST Program term, if the SBC FAST Program has not been grandfathered, a conversion may be made to a new 3-year SBC FAST Program term. The SBC FAST Program term must occur between the same two termination points as the original service being converted and will become effective upon completion of the conversion activity. The rates, terms, and conditions applicable for the new 3-year SBC FAST Program term will be those in effect at the time the conversion is completed. Administrative Charges will apply for the conversion of an existing SBC FAST Program term to a new 3-year SBC FAST Program.

(c) Upgrading an existing SBC FAST Program service to a Higher Speed Service

At any time during the SBC FAST Program term, service may be upgraded to a higher speed service. The new higher speed service must occur between the same two termination points as the original service being upgraded. The new higher speed service must be on a new term contract that has an expiration date beyond the expiration date of the SBC FAST Program term being terminated. The rates, terms, and conditions applicable for the new contract term of the higher speed service will be those in effect at the time the conversion is completed. Nonrecurring installation and ordering charges associated with the higher speed service are applicable.

(d) Conversion from existing Month-to-Month service to a new SBC FAST Program Term

Customers may convert from existing month-to-month service to a new 3-year SBC FAST Program term. If there are no physical changes to service, the Administrative Order Charge will apply. If physical changes occur, the activity would be classified as a termination of the month-to-month service and installation of a new 3-year SBC FAST Program term. Customer will be responsible for all nonrecurring installation and ordering charges associated with the new SBC FAST Program term.

(5) DS1 or DS3 Moves

During an SBC FAST Program term a customer may move one end of a DS1 or DS3 SBC FAST Program Service to another location in the same LATA and keep the DS1 or DS3 SBC FAST Program in force provided the following requirements are met:

- (a) The minimum in-service period at the previous location must have been met. The new location will be subject to a new minimum in-service period;
- (b) The move is accommodated on a single customer order with the stipulation that the Billing Account Number (BAN), the Network Channel Code (NC), Access Customer Terminal Location (ACTL) and the Circuit ID (ECCKT) are provided and are the same as for the existing circuit being moved. Moves to a different wire center may result in change in the application of the rate elements associated with the service and therefore could result in a change in the monthly recurring charges.

If no lapse in service occurs and if the requirements in (a) and (b) as stated previously are met, termination liability will not apply. Nonrecurring Charges and Administrative Order Charge for the physical move will apply.

(6) Termination Liability

When an SBC FAST customer's disconnection is governed by the Federal Acquisition Regulations, then the termination provisions found in the Federal Acquisition Regulations apply.

When SBC FAST customer's disconnection is not governed by the termination provisions of the Federal Acquisition Regulations, a termination charge will be calculated as follows:

(Monthly Recurring SBC FAST rate) X (number of net terminated SBC FAST circuits subject to Termination Charges) X (months remaining in SBC FAST term) X (50.00%).

Example: An agent of the Federal Government disconnects one SBC FAST DS1 in month 30 of the 36 month term. The monthly recurring charge for the DS1 is \$300.00. The reason for the disconnection is the Agent is going to use another company's facilities to provide the Federal Government with service. Termination liability charges will be calculated as follows:
 $\$300.00 \times 1 \times 6 \text{ mos.} \times .50 = \900.00

Government Emergency Telecommunications Service (GETS) is an emergency Telecommunications Service developed for the Federal Government. This service provides enhanced call routing and processing to authorized government users with enhanced call completion during natural and man made disasters, using the survivable public switched network (PSN) resources, and the reserved 710 Numbering Plan Area (NPA) code. Calls will use the two Advanced Intelligent Network (AIN) features, Alternate Carrier Routing (ACR) and Calling Party Number. Rates and charges are shown in section 10.7.1(F)(2) following.

(1) Alternate Carrier Routing (ACR) Feature

(N)

The Alternate Carrier Routing (ACR) feature will provide the GETS caller dialing the 1+710-NCS-GETS access number routing to one of three predetermined Interexchange Carriers (IXCs) as determined by the governments agent.

Calling Party Number (CPN) is a feature that when activated will allow the 710-NCS-GETS number to be displayed as the calling party. If this feature is not activated, then the calling party's local exchange number will be displayed.

Access Code Activation and Call Routing Plan setup are the processes used to open and verify the 710 area code in all class 5 end offices, and implement the appropriate call routing plans.

Specialized call data reports will contain call routing information. These reports will be available monthly upon request and may be used at the time of a national disaster.

Operations, Maintenance, Usage Reports are the ongoing network functions that are provided monthly or quarterly with this service.

GETS HPC changes the priority assigned to the call setup message for an 710-NCS-GETS in the Signaling System 7 (SS7) network. Setup messages associated with calls to 1-710-NCS-GETS will be sent with the highest priority. GETS HPC also provides a trunk queuing feature in equipped switches which is invoked any time an Interexchange Carrier (IC) trunk group is busy. The queuing is only applicable to GETS calls. Queuing allows callers to 710-NCS GETS users to dial an emergency call one time and not encounter a busy signal. The call will be placed in queue and automatically complete when the first available trunk becomes idle.

(a) GETS HPC Service Features(1) GETS Call Recognition

This feature sets a trigger to recognize originating GETS calls based on the called number. The screen will be set on 710-NCS GETS on all switches and on four specific 800/888 numbers that provide access to GETS in certain switches only. A call to 710-NCS-GETS is marked as an HPC call.

(2) Trunk Group Queuing (TQ)

This feature provides the capability to queue HPC marked calls on specific trunk groups within the routing chain. Only HPC marked calls are allowed to queue.

(3) Exemption From Network Management Controls (EX-NMCs)

This feature provides HPC marked calls exemption from restrictive Network Management Controls that are invoked during times of excessive traffic on the Public Switched Telephone Network.
