**Note 5:** Final Route Arrangements require an ERS Remote Telephone Number (RTN) and an ERS Final Route Telephone Number (FTN). RTNs are not available in 1AESS central offices.

**Note 6:** Effective May 1, 2014, customers may not add the Digital Data Only option, and existing term plans for this option may not be renewed.
