PURPOSE: BellSouth Telecommunications, LLC d/b/a AT&T Florida intends to retire copper facilities serving distribution area (DA) 220205 in the Kings Point wire center (DLBHFLKP) in Delray Beach, FL due to the impact of a Florida Department of Transportation (FDOT) planned road construction project. This project will improve Barwick Road from Atlantic Avenue to Lake Ida Road with a focus on pedestrian and bicycle accommodation. FDOT has requested AT&T Florida to remove or relocate its facilities in the way of this project before January 30, 2025. Florida plans to migrate customers currently served by copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and then retire the copper facilities.
