FDOT has requested that AT&T Florida remove or relocate its facilities in the way of this project before January 30, 2026.ons, LLC d/b/a AT&T Florida (AT&T Florida) intends to retire copper facilities serving Distribution Areas (DAs) 310603 and 314860 in the Palatka Wire Center (PLTKFLMA) in Palatka, FL due to the impact of a planned Florida Department of Transportation (FDOT) underground construction project (FDOT 449129-1-52-01) SR 20 Putnam County. FDOT has requested that AT&T Florida remove or relocate its facilities in the way of this project before January 30, 2026.igrate customers currently served by copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and then retire the copper facilities.
