A move charge, per MegaLink service channel under CSPP, applies for each MegaLink service moved to a new location in Company territory within the same state. This move charge is equal to the sum of all nonrecurring charges applicable to a new MegaLink service channel installation at the new location.

C. Conditioning (Voice Grade Services)

1. Conditioning provides more specific transmission characteristics for data services. There are two types of C-conditioning and one type of D-conditioning, each with different technical specifications. C-Type conditioning controls attenuation distortion and envelope delay distortion. D-Type conditioning controls the signal to C-notched noise ratio and inter-modulation distortion.

Conditioning is charged for on a per Local Channel basis for two-point and multi-point service. For two-point services the parameters apply to each service. For multipoint services the parameters apply to any path between any two service points.
