A. Terms and Conditions

1. General

- a. Series 1100, Types 1101 and 1102 private line channel service provides for the transmission of binary signals at rates up to 150 baud within the specifications and limits as stated in B. following.
- b. Direct Served Channels not routed via the Central Office (non-continuous property) are limited to one mile in length and are available only at the economic option of the Company.

B. Types and Descriptions

In consideration of the decreasing supply of metallic facilities required to provide Local Area Data Channels, the Company will convert a customer's service to a voice grade service or SynchroNet service and waive the nonrecurring charges associated with the change. - **A.** Series 6000 private line service provides for one way audio transmission for use in connection with loudspeaker and sound recording equipment. Channels are furnished for operation on a two point or multipoint basis for service 7 days per week, 24 hours per day, for a minimum period of one month. These channels are arranged for use with customer-provided station equipment only.
