Descriptive Narrative:	BellSouth Telecommunications, LLC d/b/a AT&T Florida (AT&T Florida) intends to retire copper facilities serving distribution area (DA) 121320 in the Ft. Lauderdale Main (FTLDFLMR) Wire Center in Fort Lauderdale, FL due to underground project property dispute with the Florida Department of Transportation (FDOT). FDOT has requested that AT&T Florida remove or relocate its facilities in the way of this project before February 30, 2026. BellSouth Telecommunications, LLC d/b/a AT&T Florida (AT&T Florida) intends to retire copper facilities serving Distribution Area (DA) 130406 in the Beach Relief Wire Center (MIAMFLBR) in Miami Beach, FL due to the impact of a planned Florida Department of Transportation (FDOT) underground construction project along North Hibiscus Drive. FDOT has requested that AT&T Florida remove or relocate its facilities in the way of this project before December 30, 2025. BellSouth Telecommunications, LLC d/b/a AT&T Florida (AT&T Florida) intends to retire copper facilities serving Distribution Areas (DAs) 410303 and 410503 in the Boynton Beach Wire Center (BYBHFLMA) in Boynton Beach, FL due to the impact of a planned Florida Department of Transportation (FDOT) road construction project along Beach Blvd. FDOT has requested that AT&T Florida remove or relocate its facilities in the way of this project before November 30, 2025. BellSouth Telecommunications, LLC d/b/a AT&T Florida (AT&T Florida) intends to retire copper facilities serving Distribution Area (DA) 342127 in the Opa Locka Wire Center (MIAMFLOL) in Miami, FL due to recurring failures caused by degraded copper facilities. While AT&T Florida technicians have temporized repairs for service restoral, the copper facilities require complete replacement as a permanent repair solution. BellSouth Telecommunications, LLC d/b/a AT&T Florida (AT&T Florida) intends to retire copper facilities serving Distribution Area (DA) 122602 in the

	Jupiter Wire Center (JPTRFLMA) in Tequest, FL due to damaged facilities of a SAI serving this DA sustained during a car accident. While AT&T Florida technicians made repairs sufficient to sustain service to affected customers, the damage degraded the copper facilities to the extent that complete replacement would be necessary as a permanent solution BellSouth Telecommunications, LLC d/b/a AT&T Florida (AT&T Florida) intends to retire copper facilities serving distribution areas (DAs) 435640, 436104, 436203, 437006, 437240, 444402, 444404, 444406 and 444408 in the Jupiter Wire Center (JPTRFLMA) in West Palm Beach, FL due to the impact of a planned Florida Department of Transportation (FDOT) road construction project along SR9 Interstate 95. FDOT has requested that AT&T Florida remove or relocate its facilities in the way of this project before December 29, 2025. AT&T Florida plans to migrate customers currently served by copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and then retire the copper facilities.
