Note 3: Effective May 1, 2014, customers may not add the Digital Data Only option, and existing term plans for this option may not be renewed.

Note 4: The Inward Data option is restricted to the Inward Only Call Type.

Note 5: Upon expiration of the CSPP, if customer has not entered into a new CSPP contract or term extension, or disconnected service, Monthly Extension rates will apply (see Paragraph A42.3.2.A.5.). Monthly Extension rates are equal to one hundred fifty percent (150%) of the customer's expiring contractual rate.
