When the customer's telephone instrument goes off-hook, a switched connection is set-up without any further customer action. The predetermined telephone number is selected by the customer at the time service is established and can be changed only via service order.
- **B.** Hot Line Service may be used only in connection with individual line service.
- C. Hot Line Service is furnished only from central offices which have been arranged to provide this service and is provided subject to the availability of facilities.
