#### A142.4.2 Terms and Conditions (Cont'd)

L. IBS lines may be purchased at a thirty percent (30%) discount for use by full-time educational institutions, public or private, teaching grades kindergarten through twelve that are accredited by the state of Georgia. This offering is also available to public libraries, including the state library and archives, regional libraries and public libraries in any county, city or town.

This service is intended for in-classroom use of computers by students to access information databases, shared educational programs and students in other classrooms. Teachers and researchers may also subscribe to this service for on-campus use. These lines shall not be used to replace existing administrative lines.

**B CHANNEL** 

A bidirectional synchronous channel capable of supporting 64 Kbps of digital transmission.

D CHANNEL

A 16 Kbps digital signaling channel also capable of supporting 9.6 Kbps of packet information for the Basic Rate Interface.

64 KBPS CLEAR CHANNEL CAPACITY (CCC)

A B channel connection that provides end-to-end digital connection in which all 64 Kbps of bandwidth are available for customer use.
