PURPOSE: BellSouth Telecommunications, LLC d/b/a AT&T Georgia intends to retire copper facilities serving distribution areas (DA) 110406 and 1108C in the Woodstock wire center (WDSTGACR) in Woodstock, GA due to the impact of a City of Woodstock planned road construction project. The city has requested AT&T Georgia to remove or relocate its facilities in the way of this project before June 30, 2025.s to migrate customers currently served by copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and then retire the copper facilities.
