PURPOSE: TDM to IP Transition - Woodstock, GA LLC d/b/a AT&T Georgia intends to retire copper facilities serving distribution area (DA) 110313 in the Woodstock (WDSTGACR) wire center in Woodstock GA due to damaged facilities of the SAI serving this DA sustained during a car accident. While AT&T Georgia technicians made repairs sufficient to sustain service to affected customers, the damage degraded the copper facilities to the extent that complete replacement would be necessary as a permanent solution. ce the copper facilities and SAI AT&T Georgia plans to migrate customers served by the copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) and then retire the copper facilities.
