The city has requested AT&T Georgia to remove or relocate its facilities in the way of this project before June 30, 2025.s to migrate customers currently served by copper facilities to existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities and then retire the copper facilities.
