This notification from Illinois Bell Telephone Company (AT&T Illinois) modifies the resale "Welcoming Rewards Promotion" that was previously filed on March 25, 2008, under Advice No. IL-08-18436P-W. Effective September 15, 2008, the "Welcoming Rewards Promotion" is amended to include AT&T Business Local Calling as a promotion eligible term payment plan. All other terms and conditions of the promotion remain unchanged as follows. The promotional period of April 1, 2008 through March 31, 2009 also remains unchanged.

Eligible business carriers customers subscribing to new access lines or trunks will receive a one-time credit based on the number of lines ordered. Promotion eligible carriers customers will receive a \$50.00 credit for the first line and a credit of \$25.00 per line for lines 2 through 20. Lines must be connected at the same location and only the first 20 lines will qualify for a credit. In addition, waivers will be provided for the normally applicable Service Ordering and Line Connection nonrecurring charges (NRCs) associated with the installation of local exchange access lines (or trunks), up to 20 lines maximum per location. This offer is only applicable at the time of placing the initial order and is not available for subsequent orders for additional lines or services.

Eligible carriers customers include new businesses, businesses that are currently with another carrier and are establishing service with the Company, or existing businesses that establish service at an additional, new location. Carriers customers must commit to an oral 1-year Welcoming Rewards Promotional Agreement in order to receive the benefits.

To qualify for the Welcoming Rewards Promotion benefits, promotion eligible carriers customers must also subscribe to AT&T Business Local Calling, SimpleLink Enhanced II, Custom BizSaver, or a Custom BizSaver Winback plan. All terms and conditions applicable to AT&T Business Local Calling, SimpleLink Enhanced II, Custom BizSaver or Custom BizSaver Winback, as appropriate, will apply. The commitment to one of the specified term plans is in addition to the oral 1-year Welcoming Rewards Promotional Agreement commitment.

Carriers customers who disconnect their account prior to completion of the oral Welcoming Rewards Promotional Agreement will be billed for all upfront Welcoming Rewards promotional credits provided as described above. These charges are in addition to other charges that may be associated with a subscription to a qualifying term plan.

This offer cannot be combined with any other promotional offers waiving/crediting NRCs or that provide credits for local exchange access lines or with the Custom BizSaver 12-month oral agreement with resubscription option geographic discount, nor with the AT&T Business Local Calling Option A and B discounts.
