

**STATION MESSAGE DETAIL RECORDING – CENTRAL OFFICE****A. General**

Effective February 1, 1999 Station Message Detail Recording - Central Office is no longer available to new customers or to existing customers expanding their current systems.

Station Message Detail Recording - Central Office (SMDR-CO) is a feature which provides a record, by station telephone number, of calls originated over WATS lines, Common Control Switching Arrangement access lines, Enhanced Private Switched Communication Service access lines, Foreign Exchange Lines, Foreign Central Office Lines, Foreign District Lines, Tie Lines or Other Common Carrier Switching System access lines. At the customer's option, station message detail is available on certain incoming calls extended by an attendant to a terminal or terminating arrangement within the Centrex system using the CDRS feature described under *Centrex Service* in Part 5, Section 1. SMDR-CO is available only to C.O. Centrex customers and is offered subject to the availability of suitable facilities. SMDR-CO is not intended to be billing detail. All call attempts, using Foreign Exchange Lines, Foreign Central Office Lines, Foreign District Lines, Tie Lines or Other Common Carrier Switching System access lines, whether completed or not, are recorded for these facilities.

SMDR-CO provides the following information:

- The calling station number
- The called telephone number
- The date and time of call
- The type of facility used
- The duration of the call

With the exception of incoming calls extended by an attendant, where the information is limited to an entry code, the called station number or access code, time of day, date and duration of the call after attendant processing.

**CONSOLIDATED SUMMARY BILLING SERVICE**

**A. General**

1. Consolidated Summary Billing Service (CSBS) provides business customers who receive multiple individual bills for telephone service a single bill due date applicable to all such bills.
2. The single bill due date is reflected on a monthly transmittal that also lists the area code, billing telephone number, customer code, current billed amount, and prior outstanding billed amount for any and all bills received by a customer are subject to the regulations below.
3. Customer may, at their option, choose not to receive their multiple individual bills.

**B. Regulations**

1. The accounts that will appear in the transmittal will be determined by the customer at the time CSBS is ordered by the customer. The customer may change these accounts on thirty (30) days prior written notice.
2. The transmittal will be prepared based on the bill date of the customer's master account and will be mailed to the customer within ten (10) days after that date.
3. For purposes of this service, the master account is the account chosen by the customer.
4. The CSBS transmittal summary constitutes the official payment document which is to be returned to the Company with the customer's remittance.
5. The customer agrees to pay the total current charges by the due date listed on the transmittal. If not paid, CSBS shall be terminated because of the administrative difficulty that would be incurred in applying late payment charges to multiple bills.
6. Service order charges shall not apply.
