CALL PLAN 30^{/1/}

Effective July 1, 2023, no further installation of or changes to Call Plan 30 will be made. Customers of Record on July 1, 2023, may continue their service as long as such service remains at the location at which it was being furnished on the aforementioned date. In the event that this service is discontinued at the present location for any reason, it will not be re-established.

A. DESCRIPTION

Call Plan 30 is an optional calling plan available to residence subscribers in MSAs 1, 2, 3, 6, 7, 9 and 15. Call Plan 30 provides a Residence Network Access Line and up to 30 calls to terminating districts in Band A and Band B^{/1/}. A per-call charge applies for each call over 30.

B. TERMS AND CONDITIONS

1. Call Plan 30 will be available to all Residence customers as described in paragraph A., including direct line, P.B.X. and Dormitory Service.
2. Residence Usage Service discounts do not apply.
3. Call Plan 30 is applicable to customer dialed station to station calls only. Operator handled calls are not included.
4. Call Plan 30 is not applicable to intra-MSA long distance calls.
5. Call Plan 30 is provided on a per-line basis.

In the event that this service is discontinued at the present location for any reason, it will not be re-established.

A. DESCRIPTION

Local Unlimited Package is an optional calling plan available to residence subscribers that provides a Residence Network Access Line and unlimited calling to terminating districts Bands A and B. In MSAs 4, 5, 10, 12, 13 and 16, Local Unlimited Package includes a Residence Network Access Line and unlimited local calls on a flat rate basis.

B. TERMS AND CONDITIONS

The terms and conditions contained herein are specific to the Local Unlimited Package and are in addition to the terms and conditions set forth in other portions of this Guidebook.

1. Local Unlimited Package will be available to all Residence customers as described in paragraph A., including direct line, P.B.X. and Dormitory Service.
2. Local Unlimited Package unlimited calling is applicable to customer dialed station-to-station calls only. Operator handled calls are not included.
3. The Local Unlimited Package unlimited calling is not applicable to intra-MSA long distance calls^{1/}.
4. Residence Usage Service discounts are not applicable to Local Unlimited Package.
5. Local Unlimited Package is provided on a per line basis.
6. Local Unlimited Package is not available on ISDN lines.
7. Service charges do not apply when establishing or changing Local Unlimited Package.
