OBSOLETE SERVICES

Items of service and equipment listed herein are obsolete. They are classified into one or more of the following:

Equipment Categories

Existing Stock Only

As of dates specified, equipment classified in this category will no longer be available from the manufacturer. New installations, additions, rearrangements, changes, and in-service moves will be made only if the equipment is available from current stock at the time of the customer's request. Maintenance for existing installations will continue for so long as replacement parts are readily available.

Additions and Maintenance Only

As of dates specified, no new installations will be permitted nor will moves be made from one address to another or to non-continuous property for items of equipment classified in this category. Additions, rearrangements, interior moves and changes will be made only if such equipment is available from current stock at the time of the customer's request. Maintenance for existing installations will continue for so long as replacement parts are readily available.

Maintenance Only

As of dates specified, equipment classified in this category will not be made available for new installations, additions, moves from one address to another, moves to non-continuous property; or for interior moves, rearrangements or changes requiring replacement of equipment. Maintenance will continue for existing installations for so long as replacement parts are readily available.

Administrative Categories

Discontinued Payment Arrangements

Contract Payment Plans - As of dates specified, Optional Payment Plans for those products and/or services classified in this category will not be permitted for new system installations. Customers paying for those products or services under the discontinued Optional Payment Plan on that date may continue to do so for the life of any applicable contract period and thereafter until such time as the service is terminated by the customer. Regulations governing the transfer of any remaining contractual obligation from one customer to another can be found in Part 2, Optional Payment Plans. Additions to the system may be made under the Non-Contract Option of the Payment Plan. Rearrangements and changes will be made as requested by the customer, pending the availability of equipment. Out-of-service moves will be made as requested by the customer.

Others - As of dates specified, payment arrangements for those products and/or services classified in this category will not be permitted for new installations. Customers paying for those products or services under the discontinued arrangement on that date may continue to do so for the life of the equipment on the same premises. Additions, rearrangements and changes may be made up to the capacity of the existing service, pending the availability of equipment. Out-of-service moves will not be permitted.

Grandfathered

No longer available for new installations, new customers or new locations. Customers utilizing equipment/services on the effective date of the "Grandfathering" may continue to do so as long as the service or equipment remains in service for the same subscriber at the same premises or so long as it can be maintained.

In those cases where an item of service or equipment is classified under both an Equipment category as well as an Administrative category, the Equipment classification will govern.
