#### **RESALE SELECTIVE ROUTING (RSR)**

#### A. DESCRIPTION

Resale Selective Routing ("RSR") is an ancillary resale service which provides a Carrier the ability to route its own Operator Services (OS) and/or Directory Assistance (DA) traffic from an Ameritech resold line, according to digits dialed, (e.g., 0+/0-, 411, 555-1212, or NPA 555-1212), to an alternate Carrier trunk group. The alternate Carrier trunk group will allow Carrier's customer originated calls to route to a Carrier selected OS and/or DA platform, or an Ameritech Traffic Operator Position System (TOPS) office for separate identification and rebranding. RSR utilizes the standard Ameritech dialing plans currently used for the Ameritech end office switch in which RSR is provided.

#### **RSR Element**

RSR provides, upon request, the option to establish any technically feasible routing by class-of-call (i.e. operator services and/or directory assistance) by developing, establishing and maintaining RSR Elements [new line class codes (LCC)] which will direct RSR calls by call type to a RSR termination as required by the Carrier.

#### **RSR Termination**

The RSR termination provides for DS1 facility/trunk group ("RSR DS1 Message Trunk") access via a 1.544 Mbps Ameritech end office switch termination. This arrangement furnishes the equivalent of 24 individual network access lines. The RSR termination is used to terminate facilities/trunks used in the completion of RSR calls.

#### **B. DEFINITIONS**

#### Rebranding

A service option using RSR by which calls are delivered to the Ameritech TOPS platform on a separate, identifiable RSR DS1 Message Trunk which allows those calls to be answered in a manner specified by the Carrier.

- 2. RSR shall be available in Ameritech end office switches where technically feasible and where Ameritech end office switch capacity permits.
- 3. A separate RSR element is required for each new LCC.
- 4. RSR elements can be purchased in increments of one RSR element per new LCC in each Ameritech end office switch where RSR is requested.
- 5. All Ameritech resold traffic for a Carrier customer shall have the same RSR pattern.
- 6. All OS and/or DA message traffic transported over RSR DS1 Message Trunks between either an Ameritech end office switch and an Ameritech TOPS office or a Carrier's own or designated third-party OS/DA platform must only be used for OS and/or DA message traffic.

- 7. When routing OS and/or DA message traffic to Ameritech's TOPS office, Carriers, in addition to subscribing to RSR, are required to subscribe to the following services:
  - Use of a minimum of one RSR DS1 Message Trunk service to route traffic from each Ameritech end office switch, serving Carrier's customers, to Ameritech's TOPS office in a non-blocking manner.
  - Use of a minimum of one RSR termination service is required to terminate facilities used in the completion of RSR calls.
  - Use of RSR Branding to announce Carrier's identity as the provider of OS and/or DA to its end users.
- 8. If using the Ameritech TOPS platform for rebranding, the Carrier is subject to the OS and/or DA charges as specified in Part 22, Section 11 of this tariff.
