With this filing, AT&T Illinois increases the rate for Residence Network Access Lines in MSAs 4, 5, 10, 12, 13 and 16 and reduces rates for Residence Additional Message Units and Residence Local Area Service Monthly Usage in MSAs 4, 5, 10, 12, 13 and 16.

These services are classified as non-competitive telecommunications services pursuant to the applicable provisions of the Public Utilities Act.

Winback Offering – Residence Access Line Service

This offer will be in effect for Carrier's eligible residence customers who have their local network access line service with another carrier and who now wish to establish their local network access service with Carrier.

Carrier's eligible customers will receive a waiver of the normally applicable nonrecurring Service Order and Line Connection charges. Nonrecurring charges waived under this discount arrangement will only apply to the network access line that the Carrier's customer brings to Carrier from their prior carrier. This offer cannot be combined with a customer's receipt of the Illinois State Telephone Assistance Program one-time credit.

Online Offer - Residence Access Line Service

This offer is available to Carrier's new and existing residential customers who establish a network access line with the Carrier via an Internet-based online order entry application that the Carrier uses to receive orders from its end users. Carrier's eligible residential customers will receive a waiver of the service ordering and line connection charges to install the network access line. This offer cannot be combined with a customer's receipt of the Illinois State Telephone Assistance Program one-time credit.

Mobility National Retail Service Connection Charge Waiver

This offer is available to Carrier's residence customers who place their order for a network access (C) line with a minimum subscription of the Illinois (IL) Complete Choice Basic package via a Mobility store or a National Retailer. Carrier's eligible residential customers will receive a waiver of the nonrecurring charges associated with adding the line, features or package. This offer cannot be combined with a customer's receipt of the Illinois State Telephone Assistance Program one-time credit.
