This notification from Illinois Bell Telephone Company dba AT&T Illinois dba AT&T Wholesale is being made pursuant to Illinois Guidebook, Part 2, Section 8, Sheet 1.

On July 07, 2017, Illinois Bell Telephone Company dba AT&T Wholesale, sent a notification to the Illinois Commerce Commission, in Advice Letter No. IW-17-0013, describing a new promotional offer.

This notification is now being made to describe an upcoming change that will expand the offer to include another group of customers, effective August 30, 2017, through December 31, 2017. The additional group of customers are those existing customers of the Carrier who communicate a desire to disconnect their lines then reconsider and keep the lines with the Carrier as part of a Bundle¹ (a "Save" customer), and who subscribe to a 12-month Term Plan for Business Local Calling (BLC) Option A. For qualifying customers, Carrier's will receive a net monthly rate of \$25 (via a \$35 credit). For a Carrier's customers participating in this offer and receiving discounts as described as "New" or "Win/Winback" in Advice Letter No. IW-17-0013, or as a "Save", as noted above, the 12-month term will be a 12-month term with an option to re-subscribe for two consecutive terms.

In addition, for Carriers' customers participating in a Business Local Calling promotion as part of a Bundle¹, with the promotional rates listed below, may continue to participate in the promotion rates if they agree to a new 12-month term with an option to re-subscribe for two consecutive terms, prior to the expiration of their existing term:

- First BLC Option A package line receiving a net monthly rate of \$50 (via a \$10 credit), and BLC Option A package lines 2-19 receiving a net monthly rate of \$25 (via a \$35 credit); or
- First BLC Option A package line receiving a net monthly rate of \$35 (via a \$25 credit), and BLC Option A package lines 2-19 receiving a net monthly rate of \$25 (via a \$35 credit).

All other terms and conditions of this offer, as described in Advice Letter No. IW-17-0013, apply.
