With this filing, AT&T Illinois decreases the rates for DS1 and DS3 services, and for AT&T Business Local Calling Assurance.

On February 14, 2020, AT&T Illinois filed Advice Nos. IW-20-0012 and IW-20-0013 to increase resale rates for the above services, effective April 3, 2020, to reflect increases in the retail prices for those service that had been scheduled to take effect on April 3. Due to the COVID-19 health emergency, AT&T Illinois has decided not to increase the retail rates as had been scheduled. Accordingly, this 45-day filing is subsequently being made to reduce the associated resale rates that will become effective on April 3 pursuant to the February 14 filing. The revised tariffs sheets being filed herewith are marked with an effective date of May 15, 2020, 45 days after the mailing date of the enclosed tariffs.

These services are classified as non-competitive telecommunications services pursuant to the applicable provisions of the Public Utilities Act. We respectfully request Commission acceptance of these sheets to become effective May 15, 2020.
