

**DID/AIOD SERVICE**

Direct Inward Dialing Service to Customer Premises Located Switching Systems

**A. General Regulations**

1. Direct Inward Dialing Service to customer-premise located switching systems is furnished subject to the availability of facilities and the availability of telephone numbers.
2. The service includes the central office switching equipment necessary for direct inward dialing from the exchange and long distance message telecommunications network directly to stations and attendant positions associated with customer-premises located switching systems.
3. The service must be provided on all lines in a trunk or Network Access Line group arranged for inward service.
4. The charges for the service, as provided in paragraph B. *Rates* following, are in addition to the applicable Network Access Line and connecting arrangement charges as provided in Part 2, Section 9.
5. Operational characteristics of interface signals between Company-provided connecting arrangements and the customer-provided switching equipment must conform to the rules and regulations the Company considers necessary to maintain proper standards of service.
6. The Company shall not be responsible to the customer or authorized user if changes in the protection criteria or in any of the facilities, operations, or procedures of the Company render any facilities provided by a customer or authorized user obsolete or require modification or alteration of such equipment or system or otherwise affect its use or performance.
7. Direct Inward Dialing telephone numbers are normally provided on a consecutive number basis. DID numbers may be provided on a non-consecutive basis when such service provision is acceptable to the customer and the Company and, is within the normal limitations of the serving office. the Company retains its rights to the administration and use of telephone numbers as described in 'Rules and Regulations Applying to All Customer's Contracts' in Part 2, Section 2.
8. Listings will be provided in accordance with the regulations of Part 12, Section 1. Direct inward dialing numbers furnished herein are not entitled to free listings. (C)

9. The customer-premises-located switching equipment must be arranged to provide for intercepting of unused numbers transmitted to the switching equipment.
10. The rates and charges for the service contemplate the use of standard Company equipment and serving arrangements.
11. Note that special steps are required for PBX customers to have 911 service features consistent with those provided to other end users in the same 911 service area. Automatic Number Identification, Automatic Location Identification and/or Selective Routing are only available through coordination with the governmental agency responsible for 911 service within the area served by the PBX in accordance with the provisions of 'Universal Emergency Number Service (911))' as described in Part 8, Section 3.

## 12. Removal and Reinstatement of Numbers

- a. The removal of one or more numbers from a DID number block is offered subject to the availability of facilities at the charge specified in paragraph B. *Rates* following. In such cases, the customer shall continue to pay the appropriate rate for the original block of DID numbers.
- b. The re-instatement of one or more numbers to a DID number block, for use by the customer, is offered, subject to the availability of facilities, at the charge specified in paragraph B. *Rates* following. In such cases, the customer shall pay the appropriate rate for the original number block of DID numbers.

13. Rates and charges for DID numbers apply on a trunk group basis. The rate and charge for an initial block of DID numbers, whether in quantities of 100 or in quantities of 10, will apply only once for each quantity. All subsequent number blocks purchased by the customer will be at the rates and charges specified for additional quantities.

14. In cases where a customer converts a block of 100 numbers into one or more blocks of 10 numbers, or vice versa, it will constitute a disconnection of the original number block(s) and the appropriate nonrecurring charges will apply to establish the new number block(s). However, the customer may be required to accept different numbers from those in the original number block(s).

15. The customer shall select a service term for each service component of either Month-to-Month, 12<sup>/2/</sup>, 24<sup>/2/</sup>, 36<sup>/2/</sup>, 48<sup>/1/</sup> or 60<sup>/1/</sup> consecutive months. For the purpose of determining the applicable monthly rates, the service term for all service components must be the same. (C)

1. If the customer selects a service term other than Month-to-Month, the customer will be required to sign an agreement. The service term cannot be changed for the duration of this agreement. The monthly rate for the service components will not be subject to rate increases for the duration of the service term. If changes reduce service term rates, the Company will apply the reduced rates prospectively to all unexpired service term agreements, as appropriate.

2. If the customer disconnects any service component prior to the expiration of the 12-<sup>/3/</sup>, 24-<sup>/3/</sup>, 36-<sup>/3/</sup>, 48<sup>/2/</sup>- or 60<sup>/2/</sup>-month service term on an agreement entered into before March 15, 2008, the customer shall pay a termination charge for the service components disconnected. If the customer disconnects any service component prior to the expiration of the 12-<sup>/3/</sup>, 24-<sup>/3/</sup>, 36-<sup>/3/</sup>, 48<sup>/2/</sup>- or 60<sup>/2/</sup>-month service term on an agreement entered into after March 14, 2008, AT&T will assess a termination charge. The early termination charge will be the sum of all unpaid special construction charges or nonrecurring charges, if any (excluding any waived charges); plus fifty percent (50%) of all recurring charges for the remaining months of Customer's Term. Termination charges will not apply if Customer converts to another AT&T telecommunications service under a term plan similar or greater in duration to the original Term Plan. In addition, early termination charges will also be waived for Direct Inward Dialing Service customers who move their service to another AT&T-served location within Kansas if the service terms are continued at the new location. This charge will also be waived should the customer convert Digital Loop Service, SuperTrunk Option of Digital Loop Service or SmartTrunk<sup>SM</sup> Service for a service term that equals or exceeds the number of months remaining on the customer's agreement. Payment of the termination charge does not release the customer from other previous amounts owed the Company. For agreements entered into before March 15, 2008, the termination charge for the SuperTrunk Port and the Switch Use elements will be the lesser of:
- a. The difference between the total rates and charges for the completed months of the original service term at the time of termination and the total rates and charges for the next lower service term<sup>/1/</sup> actually completed plus interest charges based on the authorized Discount Rate of 11.8% as specified in 'Rules and Regulations Applying to All Customer's Contracts' in Part 2, Section 2.
  - OR
  - b. The monthly payments remaining on the service term for the service components.

Example: If the customer completes 26 months of a 36-month service term, the first calculation of a termination charge equals the difference between 26 months of rates and charges at the 36-month service term and 26 months of rates and charges at the 24-month service term (which is the next lower service term actually completed), plus interest at the authorized Discount Rate in effect at the time of termination. The second calculation will be the sum of the ten remaining monthly payments on the 36-month service term. The termination charge is the lesser of the two calculations.

For agreements entered into after March 14, 2008, the termination charges will be based on the 50% methodology described above in paragraph A.2.

3. If additional service components are ordered at a location where the customer has an existing Direct Inward Dialing Service term pricing agreement, the additional service(s) may be added to that agreement, so that the monthly rate and expiration date specified in the original agreement apply. As an alternative, the customer may choose the Month-to-Month payment option for the service additions. The service terms for all additional service components must be the same as the original term agreement.
4. Upon expiration of the service term, the customer may:
  - Continue service without establishing a new service term. Service will be provided on a month-to-month basis at the then current rate. This monthly rate will be subject to any rate changes.
  - Discontinue the service.
5. If a service term agreement expires and the customer has not notified the Company regarding the option selected, service will continue at the monthly rate in effect at the time for the Month-to-Month option.

Automatic Identified Outward Dialing Service from Customer-Premises Located Switching Systems

**A. General Regulations**

1. Automatic identified outward dialing service from customer premises located switching systems is furnished subject to equipment and facility limitations and the availability of telephone numbers.
2. The service includes the central office equipment necessary for the identification of outgoing Long Distance Message Telecommunications Service messages by station number. The billing of messages by station number is the responsibility of the interexchange carrier providing the long-distance service connection. The billing of messages by station is limited to the cases where the interexchange carrier subscribes to the Company's Billing and Recording service as provided in Section 8 of the Access Service Tariff.

The service provides for the identification of outgoing Long Distance Message Telecommunications Service messages and the billing of these messages by station number where the Long Distance Message Telecommunications Service is provided by the Company.

3. The service is normally provided on calls placed over trunks or Network Access Lines from the local serving central office. Where AIOD is not available in the customer's local serving central office, it may be provided from a distant serving central office subject to the availability of facilities. In such a case the trunks or Network Access Lines, over which outward calling takes place, must be served from the AIOD serving office.
4. The service must be provided on all lines in a trunk or Network Access Line group. Where the service is requested and provided on more than one trunk or Network Access Line group, each such group will be considered a separate service in determining charges.
5. The charges for the service as provided in B. *Rates* following are in addition to the applicable Network Access Line and connecting arrangement charges as provided in Part 2, Section 9.
6. Operational characteristics of interface signals between the Company-provided connecting arrangements and the customer-provided communication system with switching equipment must conform to the rules and regulations the Company considers necessary to maintain proper standards of service.
7. The Company shall not be responsible to the customer or authorized user if changes in protection criteria or in any of the facilities, operations or procedures of the Company render any facilities provided by a customer or authorized user obsolete or require modification or alteration of such equipment or system or otherwise affect its use or performance.
8. The rates and charges for the service contemplate the use of standard Company equipment and serving arrangements.
