This Tariff contains regulations and rates applicable for the furnishing of, General Exchange, Long Distance Message Telecommunications Service, Mobile Telephone Service, Wide Area Telecommunications Service and for other General Subscriber Services, equipment and facilities associated with the preceding services offered by BellSouth Telecommunications, LLC within this State.¹ This Tariff is on file with the Kentucky Public Service Commission.

Intrastate Communication Services are furnished through facilities provided by the Company for the transmission of intelligence by electrical impulse, principally by means of wire, radio or a combination thereof.

The Company may discontinue certain Company services in geographic areas for which the Company has no customers subscribing to those services.

In addition and subject to the appropriate regulatory approvals, the Company may grandfather all services governed by this Tariff in certain geographic areas. Once grandfathered, such services will no longer be available for purchase and existing customers will no longer be able to move, add or change their existing service.²
