# A13.11 Remote Call Forwarding (Cont'd)

#### A13.11.1 General (Cont'd)

K. For the purpose of administering A2.3.6 (Application of Rates for Business and Residence Service) and A13.24 (Extension Service), the Company's central office location of the RCF telephone number shall not be considered as a terminating premises of the service to which calls are forwarded.

The minimum contract period for this service is one month.

# A13.11.5 Rates And Charges

The following charges are for the Remote Call Forwarding feature only and are in addition to applicable charges for service and equipment with which it is used.

Where customers have fifteen or more unique RCF features on a billing account, a credit of twenty five percent (25%) will be applied per billing cycle to the monthly rate for each such unique service feature, including the first fifteen. For purposes of qualifying for such credit, a unique feature is defined by calling scope, jurisdiction and business/residence classification: e.g., Residence, Intratate, IntraLATA; or, Business, Measured Local. Additional features (Access Paths) also qualify as a unique feature. Unique features may not be combined to qualify for this credit; e.g., local features may not be combined with toll features.
